A BILL

Making appropriations for Coast Guard pay in the event an appropriations Act expires before the enactment of a new appropriations Act.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Pay Our Coast Guard
- 5 Parity Act of 2019".
- 6 SEC. 2. APPROPRIATIONS FOR THE COAST GUARD.
- 7 There are hereby appropriated, out of any money in
- 8 the Treasury not otherwise appropriated, for any period

1	during fiscal year 2019 during which interim or full-year
2	appropriations for the Coast Guard are not in effect—
3	(1) such sums as are necessary to provide pay
4	and allowances to members of the Coast Guard (as
5	described in section 1 of title 14, United States
6	Code), including the reserve component thereof, who
7	perform active service or inactive-duty training dur-
8	ing such period;
9	(2) such sums as are necessary to provide pay
10	and allowances to civilian employees of the Coast
11	Guard;
12	(3) such sums as are necessary to provide pay
13	and allowances to contractors of the Coast Guard;
14	(4) such sums as are necessary for—
15	(A) the payment of a death gratuity under
16	sections 1475 through 1477 and 1489 of title
17	10, United States Code, with respect to mem-
18	bers of the Coast Guard;
19	(B) the payment or reimbursement of au-
20	thorized funeral travel and travel related to the
21	dignified transfer of remains and unit memorial
22	services under section 481f of title 37, United
23	States Code, with respect to members of the
24	Coast Guard: and

1	(C) the temporary continuation of a basic
2	allowance of housing for dependents of mem-
3	bers of the Coast Guard dying on active duty,
4	as authorized by section 403(l) of title 37
5	United States Code; and
6	(5) such sums as are necessary to provide for
7	Coast Guard retired pay, including such payments
8	as are described in the provision regarding Coast
9	Guard retired pay in title II of division F of the
10	Consolidated Appropriations Act, 2018 (Public Law
11	115–141; 132 Stat. 348).

1 SEC. 4. COMPENSATION FOR LAPSE IN APPROPRIATIONS.

- 2 (a) Furloughed Employees.—Civilian employees
- 3 of the Coast Guard furloughed as a result of a lapse in
- 4 appropriations beginning on or about December 22, 2018,
- 5 and ending on the date of the enactment of this Act shall
- 6 be compensated at their standard rate of compensation,
- 7 for the period of such lapse in appropriations, as soon as
- 8 practicable.
- 9 (b) AUTHORITY.—All obligations incurred in antici-
- 10 pation of the appropriations made and authority granted
- 11 by this Act for the purposes of maintaining the essential
- 12 level of activity to protect life and property and bringing
- 13 about orderly termination of Government functions, and
- 14 for purposes as otherwise authorized by law, are hereby
- 15 ratified and approved if otherwise in accord with the provi-
- 16 sions of this Act.
