### **AN ACT**

- To amend the Public Health Service Act to improve essential oral health care for low-income and other underserved individuals by breaking down barriers to care, and for other purposes.
  - 1 Be it enacted by the Senate and House of Representa-
  - 2 tives of the United States of America in Congress assembled,

#### 1 SECTION 1. SHORT TITLE.

2 This Act may be cited as the "Action for Dental3 Health Act of 2017".

4 SEC. 2. VOLUNTEER DENTAL PROJECTS AND ACTION FOR
5 DENTAL HEALTH PROGRAM.

6 Section 317M of the Public Health Service Act (42
7 U.S.C. 247b-14) is amended—

8 (1) by redesignating subsections (e) and (f) as
9 subsections (f) and (g), respectively;

10 (2) by inserting after subsection (d) the fol-11 lowing new subsection:

12 "(e) Action for Dental Health Program.—

"(1) IN GENERAL.—The Secretary, in consulta-13 14 tion with the Director of the Centers for Disease Control and Prevention and the Administrator of the 15 16 Health Resources and Service Administration, may 17 award grants to or enter into contracts with eligible 18 entities to collaborate with State, county, or local 19 public officials and other stakeholders to develop and 20 implement initiatives to accomplish any of the fol-21 lowing goals:

"(A) To improve oral health education and
dental disease prevention, including through
community-wide prevention programs, through
the use of dental sealants and fluoride varnish,
and by increasing oral health literacy.

1	"(B) To reduce geographic barriers, lan-
2	guage barriers, cultural barriers, and other
3	similar barriers to the provision of dental serv-
4	ices.
5	"(2) ELIGIBLE ENTITY.—In this subsection, the
6	term 'eligible entity' means an entity that is—
7	"(A) a State or local dental association;
8	"(B) a State oral health program;
9	"(C) a dental education, dental hygiene, or
10	postdoctoral dental education program accred-
11	ited by the Commission on Dental Accredita-
12	tion; or
13	"(D) a community-based organization
14	that—
15	"(i) partners with an academic insti-
16	tution;
17	"(ii) is exempt from tax under section
18	501(c) of the Internal Revenue Code of
19	1986; and
20	"(iii) partners with public and private
21	stakeholders to facilitate the provision of
22	dental services for underserved popu-
23	lations."; and
24	(3) in subsection (g), as redesignated by para-
25	graph (1), by striking "such sums as may be nec-

1	essary for each of the fiscal years 2001 through
2	2005" and inserting "\$18,000,000 for each of the
3	fiscal years 2018 through 2022".
4	SEC. 3. GRANTS FOR INNOVATIVE PROGRAMS.
5	Section 340G of the Public Health Service Act (42
6	U.S.C. 256g) is amended—
7	(1) in subsection $(b)(5)$ —
8	(A) in subparagraph (B), by striking
9	"and" at the end; and
10	(B) by adding at the end the following:
11	"(D) the establishment of dental homes for
12	children and adults, including for the aged,
13	blind, and disabled populations;
14	"(E) the establishment of initiatives to re-
15	duce the use of emergency departments by indi-
16	viduals who seek dental services more appro-
17	priately delivered in a dental primary care set-
18	ting; and
19	"(F) the provision of dental care to nurs-
20	ing home residents;"; and
21	(2) in subsection (f), by striking <sup>(\$25,000,000)</sup>
22	for the 5-fiscal year period beginning with fiscal year

2008" and inserting "\$13,903,000 for each of fiscal
 years 2018 through 2022".
