A BILL

To amend title 18, United States Code, to prohibit interfering with voter registration, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Alice Paul Voter Pro-

5 tection Act".

1SEC. 2. PROHIBITING HINDERING, INTERFERING WITH, OR2PREVENTING VOTER REGISTRATION.

3 (a) IN GENERAL.—Chapter 29 of title 18, United
4 States Code is amended by adding at the end the following
5 new section:

6 "§612. Hindering, interfering with, or preventing 7 registering to vote

8 "(a) PROHIBITION.—It shall be unlawful for any per-9 son, whether acting under color of law or otherwise, to 10 corruptly hinder, interfere with, or prevent another person 11 from registering to vote or to corruptly hinder, interfere 12 with, or prevent another person from aiding another per-13 son in registering to vote.

14 "(b) ATTEMPT.—Any person who attempts to commit
15 any offense described in subsection (a) shall be subject to
16 the same penalties as those prescribed for the offense that
17 the person attempted to commit.

18 "(c) PENALTY.—Any person who violates subsection
19 (a) shall be fined under this title, imprisoned not more
20 than 5 years, or both.".

(b) CLERICAL AMENDMENT.—The table of sections
for chapter 29 of title 18, United States Code is amended
by adding at the end the following new item:

"612. Hindering, interfering with, or preventing registering to vote.".

24 (c) EFFECTIVE DATE.—The amendments made by
25 this section shall apply with respect to elections held on

or after the date of the enactment of this Act, except that
 no person may be found to have violated section 612 of
 title 18, United States Code (as added by subsection (a)),
 on the basis of any act occurring prior to the date of the
 enactment of this Act.

6 SEC. 3. ESTABLISHMENT OF BEST PRACTICES.

7 (a) BEST PRACTICES.—Not later than 180 days after 8 the date of the enactment of this Act, the Election Assist-9 ance Commission shall develop and publish recommenda-10 tions for best practices for States to use to deter and prevent violations of section 612 of title 18, United States 11 Code (as added by section 2), and section 12 of the Na-12 13 tional Voter Registration Act of 1993 (52 U.S.C. 20511) (relating to the unlawful interference with registering to 14 15 vote, or voting, or attempting to register to vote or vote), including practices to provide for the posting of relevant 16 information at polling places and voter registration agen-17 cies under such Act, the training of poll workers and elec-18 tion officials, and relevant educational materials. For pur-19 poses of this subsection, the term "State" includes the 20 21 District of Columbia, the Commonwealth of Puerto Rico, 22 Guam, American Samoa, the United States Virgin Is-23 lands, and the Commonwealth of the Northern Mariana 24 Islands.
