## RESOLUTION

Providing for consideration of the bill (H.R. 6395) to authorize appropriations for fiscal year 2021 for military activities of the Department of Defense and for military construction, to prescribe military personnel strengths for such fiscal year, and for other purposes; providing for

consideration of the bill (H.R. 7027) making additional supplemental appropriations for disaster relief requirements for the fiscal year ending September 30, 2020, and for other purposes; providing for consideration of the bill (H.R. 7327) making additional supplemental appropriations for disaster relief requirements for the fiscal year ending September 30, 2020, and for other purposes; and providing for consideration of the Senate amendments to the bill (H.R. 1957) to amend the Internal Revenue Code of 1986 to modernize and improve the Internal Revenue Service, and for other purposes.

1       *Resolved*, That upon adoption of this resolution it  
 2 shall be in order to consider in the House the bill (H.R.  
 3 6395) to authorize appropriations for fiscal year 2021 for  
 4 military activities of the Department of Defense and for  
 5 military construction, to prescribe military personnel  
 6 strengths for such fiscal year, and for other purposes. All  
 7 points of order against consideration of the bill are waived.  
 8 In lieu of the amendment in the nature of a substitute  
 9 recommended by the Committee on Armed Services now  
 10 printed in the bill, an amendment in the nature of a sub-  
 11 stitute consisting of the text of Rules Committee Print  
 12 116–57 shall be considered as adopted. The bill, as  
 13 amended, shall be considered as read. All points of order  
 14 against provisions in the bill, as amended, are waived. The  
 15 previous question shall be considered as ordered on the  
 16 bill, as amended, and on any further amendment thereto,  
 17 to final passage without intervening motion except: (1) one

1 hour of debate equally divided and controlled by the chair  
2 and ranking minority member of the Committee on Armed  
3 Services; (2) the further amendments described in section  
4 2 of this resolution; (2) the amendments en bloc described  
5 in section 3 of this resolution; and (4) one motion to re-  
6 commit with or without instructions.

7       SEC. 2. After debate pursuant to the first section of  
8 this resolution, each further amendment printed in the re-  
9 port of the Committee on Rules not earlier considered as  
10 part of amendments en bloc pursuant to section 3 of this  
11 resolution shall be considered only in the order printed in  
12 the report, may be offered only by a Member designated  
13 in the report, shall be considered as read, shall be debat-  
14 able for the time specified in the report equally divided  
15 and controlled by the proponent and an opponent, may  
16 be withdrawn by the proponent at any time before the  
17 question is put thereon, shall not be subject to amend-  
18 ment, and shall not be subject to a demand for division  
19 of the question.

20       SEC. 3. It shall be in order at any time after debate  
21 pursuant to the first section of this resolution for the chair  
22 of the Committee on Armed Services or his designee to  
23 offer amendments en bloc consisting of further amend-  
24 ments printed in the report of the Committee on Rules  
25 accompanying this resolution not earlier disposed of.

1 Amendments en bloc offered pursuant to this section shall  
2 be considered as read, shall be debatable for 30 minutes  
3 equally divided and controlled by the chair and ranking  
4 minority member of the Committee on Armed Services or  
5 their respective designees, shall not be subject to amend-  
6 ment, and shall not be subject to a demand for division  
7 of the question.

8       SEC. 4. All points of order against the further amend-  
9 ments printed in the report of the Committee on Rules  
10 or amendments en bloc described in section 3 of this reso-  
11 lution are waived.

12       SEC. 5. Upon adoption of this resolution it shall be  
13 in order to consider in the House the bill (H.R. 7027)  
14 making additional supplemental appropriations for dis-  
15 aster relief requirements for the fiscal year ending Sep-  
16 tember 30, 2020, and for other purposes. All points of  
17 order against consideration of the bill are waived. An  
18 amendment in the nature of a substitute consisting of the  
19 text of Rules Committee Print 116-58 shall be considered  
20 as adopted. The bill, as amended, shall be considered as  
21 read. All points of order against provisions in the bill, as  
22 amended, are waived. Clause 2(e) of rule XXI shall not  
23 apply during consideration of the bill. The previous ques-  
24 tion shall be considered as ordered on the bill, as amended,  
25 and on any further amendment thereto, to final passage

1 without intervening motion except: (1) one hour of debate  
2 equally divided among and controlled by the chair and  
3 ranking minority member of the Committee on Appropria-  
4 tions and the chair and ranking minority member of the  
5 Committee on Education and Labor; and (2) one motion  
6 to recommit with or without instructions.

7       SEC. 6. Upon adoption of this resolution it shall be  
8 in order to consider in the House the bill (H.R. 7327)  
9 making additional supplemental appropriations for dis-  
10 aster relief requirements for the fiscal year ending Sep-  
11 tember 30, 2020, and for other purposes. All points of  
12 order against consideration of the bill are waived. The bill  
13 shall be considered as read. All points of order against  
14 provisions in the bill are waived. Clause 2(e) of rule XXI  
15 shall not apply during consideration of the bill. The pre-  
16 vious question shall be considered as ordered on the bill  
17 and on any amendment thereto to final passage without  
18 intervening motion except: (1) one hour of debate equally  
19 divided among and controlled by the chair and ranking  
20 minority member of the Committee on Appropriations and  
21 the chair and ranking minority member of the Committee  
22 on Ways and Means; and (2) one motion to recommit.

23       SEC. 7. Upon adoption of this resolution it shall be  
24 in order to take from the Speaker's table the bill (H.R.  
25 1957) to amend the Internal Revenue Code of 1986 to

1 modernize and improve the Internal Revenue Service, and  
2 for other purposes, with the Senate amendments thereto,  
3 and to consider in the House, without intervention of any  
4 point of order, a single motion offered by the chair of the  
5 Committee on Natural Resources or his designee that the  
6 House concur in the Senate amendments. The Senate  
7 amendments and the motion shall be considered as read.  
8 The motion shall be debatable for one hour equally divided  
9 and controlled by the chair and ranking minority member  
10 of the Committee on Natural Resources. The previous  
11 question shall be considered as ordered on the motion to  
12 its adoption without intervening motion or demand for di-  
13 vision of the question.

14 SEC. 8. House Resolution 967, agreed to May 15,  
15 2020 (as amended by House Resolution 1017, agreed to  
16 June 25, 2020) is amended—

17 (1) in section 4, by striking "July 31, 2020"  
18 and inserting "September 21, 2020";

19 (2) in section 11, by striking "legislative day of  
20 July 31, 2020" and inserting "calendar day of Sep-  
21 tember 20, 2020"; and

22 (3) in section 12, by striking "July 31, 2020"  
23 and inserting "September 21, 2020".
