## 1 SECTION 1. SHORT TITLE.

2 This Act may be cited as the "Federal Register Print-3 ing Savings Act of 2017". 4 SEC. 2. RESTRICTIONS ON DISTRIBUTION OF FREE PRINT-5 ED COPIES OF FEDERAL REGISTER TO MEM-6 BERS OF CONGRESS AND FEDERAL EMPLOY-7 EES. 8 (a) RESTRICTIONS.—Section 1506 of title 44, United 9 States Code, is amended— 10 (1) by striking "The Administrative Committee" and inserting "(a) COMPOSITION; DUTIES.— 11 12 The Administrative Committee"; (2) in subsection (a)(4), by striking "the num-13 14 ber of copies" and inserting "subject to subsection 15 (b), the number of copies"; and 16 (3) by adding at the end the following new sub-17 section: 18 "(b) RESTRICTIONS ON DISTRIBUTION OF FREE 19 PRINTED COPIES TO MEMBERS OF CONGRESS AND OFFI-20 CERS AND EMPLOYEES OF THE UNITED STATES.— 21 "(1) PROHIBITING SUBSCRIPTION TO PRINTED 22 COPIES WITHOUT REQUEST.—Under the regulations 23 prescribed to carry out subsection (a)(4), the Direc-24 tor of the Government Publishing Office may not 25 provide a printed copy of the Federal Register with-

1	out charge to any Member of Congress or any other
2	office of the United States during a year unless—
3	"(A) the Member or office requests a
4	printed copy of a specific issue of the Federal
5	Register; or
6	"(B) during that year or during the pre-
7	vious year, the Member or office requested a
8	subscription to printed copies of the Federal
9	Register for that year, as described in para-
10	graph (2).
11	"(2) Administration of subscriptions.—
12	The regulations prescribed to carry out subsection
13	(a)(4) shall include—
14	"(A) provisions regarding notifications to
15	offices of Members of Congress and other of-
16	fices of the United States of the restrictions of
17	paragraph (1);
18	"(B) provisions describing the process by
19	which Members and other offices may request a
20	specific issue of the Federal Register for pur-
21	poses of paragraph $(1)(A)$ ; and
22	"(C) provisions describing the process by
23	which Members and other offices may request a
24	subscription to the Federal Register for pur-
25	poses of paragraph (1)(B), except that such

regulations shall limit the period for such a
subscription to not longer than 1 year.".
(b) EFFECTIVE DATE.—The amendment made by
subsection (a) shall take effect January 1, 2018.
