## Harford County - Alcoholic Beverages - Resort Complex License

3 FOR the purpose of establishing in Harford County a resort complex license; authorizing 4 the Board of License Commissioners for Harford County to issue one resort complex 5 license to a certain person; specifying that the license authorizes the holder to sell 6 beer, wine, and liquor at certain outlets in the resort complex; establishing the days 7 and times during which a license holder may serve alcoholic beverages; exempting 8 the resort complex license from a certain license quota or restriction; establishing 9 that certain areas in a resort complex may be excluded from the licensed premises; establishing a certain license fee; defining a certain term; and generally relating to 10 11 alcoholic beverages licenses in Harford County.

- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

- 2 **HOUSE BILL 1272** 1 This title applies only in Harford County. 2 22-1005.2. 3 (A) IN THIS SECTION, "RESORT COMPLEX" MEANS A PARCEL OR CONTIGUOUS PARCELS OF LAND: **(1)** 5 OF AT LEAST 10 ACRES; **(2)** 6 UNDER COMMON OWNERSHIP; AND 7 **(3)** WITH FACILITIES THAT: 8 INCLUDE LODGING, CONFERENCE SPACES, (I)9 SPACES, ACTIVE OUTDOOR OPEN SPACES, WATERFRONT BEACH ACTIVITIES, OR A 10 MARINA; 11 (II) SERVE THE PUBLIC; AND 12 (III) RESULTED IN A CAPITAL INVESTMENT OF AT LEAST 13 \$500,000 EXCLUSIVE OF THE COST OF THE LAND. (B) 14 THERE IS A RESORT COMPLEX LICENSE. 15 (C) THE BOARD MAY ISSUE ONE RESORT COMPLEX LICENSE TO THE PERSON OWNING, LEASING, OR OPERATING A RESORT COMPLEX. 16 17 (D) THE LICENSE AUTHORIZES THE LICENSE HOLDER TO SELL BEER, WINE, AND LIQUOR FROM: 18 19 **(1)** ONE OR MORE OUTLETS IN THE RESORT COMPLEX THAT MAY BE 20CONSUMED IN CONJUNCTION WITH RECREATION OR THE PLAYING OF MUSIC AND DANCING AT DESIGNATED LOCATIONS IN THE RESORT COMPLEX; 2122**(2)** ONE OR MORE OUTLETS IN THE RESORT COMPLEX THAT OPERATE 23AS A RESTAURANT:
- 24**(3)** BARS OR COUNTERS AT ONE OR MORE LOCATIONS IN THE RESORT 25COMPLEX DAILY FOR ON-PREMISES CONSUMPTION;
- 26 **(4)** ONE DESIGNATED OUTLET IN THE RESORT COMPLEX FOR 27CULINARY EDUCATION AND ENTERTAINMENT WHICH MAY INCLUDE OFF-PREMISES 28**CONSUMPTION; AND**

- ONE DESIGNATED OUTLET IN THE RESORT COMPLEX FOR 1 **(5)** 2 OFF-PREMISES CONSUMPTION. 3 **(E)** A LICENSE HOLDER MAY SERVE ALCOHOLIC BEVERAGES: **(1)** AT ONE OR MORE OUTSIDE OUTLETS IN THE RESORT COMPLEX ON 4 MONDAY THROUGH SUNDAY, FROM 6 A.M. TO MIDNIGHT; 5 **(2)** 6 AT ONE OR MORE INSIDE OUTLETS IN THE RESORT COMPLEX: 7 ON MONDAY THROUGH SATURDAY, FROM 6 A.M. TO 2 A.M. (I)8 THE FOLLOWING DAY; AND 9 (II) ON SUNDAY, FROM 6 A.M. TO MIDNIGHT; AND 10 **(3)** AT ONE DESIGNATED OUTLET FOR OFF-PREMISES CONSUMPTION: ON MONDAY THROUGH SATURDAY, FROM 6 A.M. TO 2 A.M. 11 **(I)** 12 THE FOLLOWING DAY; AND 13 (II)ON SUNDAY, FROM 6 A.M. TO MIDNIGHT. A RESORT COMPLEX LICENSE IS EXEMPT FROM ANY QUOTA OR 14 RESTRICTION ON OFF-SALE LICENSES ISSUED FOR THE ELECTION DISTRICT IN 15 WHICH THE RESORT COMPLEX IS LOCATED. 16 17 (G) **(1)** CERTAIN AREAS IN A RESORT COMPLEX MAY BE EXCLUDED FROM 18 THE PORTION OF THE PROPERTY THAT IS CONSIDERED TO BE THE LICENSED 19 PREMISES. 20 **(2)** A PERSON OTHER THAN THE RESORT COMPLEX LICENSE HOLDER 21MAY OBTAIN A DIFFERENT CLASS OF LICENSE FOR AN AREA EXCLUDED UNDER PARAGRAPH (1) OF THIS SUBSECTION. 22
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2020.

THE ANNUAL LICENSE FEE IS \$3,500.
