Mr. Delgado (for himself, Mr. Smith of New Jersey, Mr. Peterson, and Mr. Zeldin) introduced the following bill; which was referred to the Committee on Oversight and Reform, and in addition to the Committee on Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned

A BILL

To provide for the issuance of a Lyme Disease Research Semipostal Stamp.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Stamp Out Lyme Dis-
- 5 ease Act".
- 6 SEC. 2. FINDINGS AND PURPOSE.
- 7 (a) FINDINGS.—Congress finds the following:
- 8 (1) According to the Tick-Borne Disease Work-
- 9 ing Group, an estimated 291,430 to 437,150 new

- 1 cases of Lyme disease were reported in the United 2 States in 2016.
- 3 (2) The Centers for Disease Control and Pre-4 vention (CDC) reports that Lyme disease is difficult 5 to diagnose due to its diverse manifestations and a 6 lack of reliable testing options.
 - (3) The National Institutes of Health (NIH) discovered that while Lyme disease symptoms can be managed with proper care, the disease currently has no cure.
- 11 (4) The Tick-Borne Disease Working Group re-12 ports that 10 to 20 percent of Lyme disease patients 13 will suffer from persistent symptoms which can be 14 chronic and disabling.
- 15 (5) According to the Johns Hopkins Bloomberg
 16 School of Public Health, Lyme disease costs the
 17 United States healthcare system up to
 18 \$1,300,000,000 dollars per year.
- 19 (b) Purpose.—To afford a convenient way for mem-20 bers of the public to contribute to funding for Lyme dis-
- 21 ease and related tick-borne illness research within the Na-
- 22 tional Institute of Allergy and Infectious Diseases, the
- 23 United States Postal Service shall issue a semipostal
- 24 stamp (hereinafter in this Act referred to as the "Lyme

- 1 Disease Research Semipostal Stamp") in accordance with
- 2 this section.

3 SEC. 3. LYME DISEASE RESEARCH SEMIPOSTAL STAMP.

- 4 (a) Terms and Conditions.—The issuance and sale
- 5 of the Lyme Disease Research Semipostal Stamp shall be
- 6 governed by the provisions of section 416 of title 39,
- 7 United States Code, and regulations issued under such
- 8 section.

(b) Disposition of Proceeds.—

- 10 (1) In general.—All amounts becoming avail-
- able from the sale of the Lyme Disease Research
- 12 Semipostal Stamp (as determined under section
- 13 416(d) of such title 39) shall be transferred to the
- 14 National Institute of Allergy and Infectious Dis-
- eases, for the purpose described in subsection (a),
- through payments which shall be made at least twice
- 17 a year.
- 18 (2) Proceeds not to be offset.—In accord-
- ance with section 416(d)(4) of such title 39,
- amounts becoming available from the sale of the
- Lyme Disease Research Semipostal Stamp (as so de-
- termined) shall not be taken into account in any de-
- cision relating to the level of appropriations or other
- Federal funding to be furnished in any year to the

- 1 National Institute of Allergy and Infectious Dis-
- eases.
- 3 (c) Duration.—The Lyme Disease Research
- 4 Semipostal Stamp shall be made available to the public
- 5 for a period of at least 6 years, beginning no later than
- 6 12 months after the date of the enactment of this Act.
- 7 (d) Definition.—For purposes of this Act, the term
- 8 "semipostal stamp" refers to a stamp described in section
- 9 416(a)(1) of title 39, United States Code.
