2	This Act may be cited as the "Protecting Nonprofits
3	from Catastrophic Cash Flow Strain Act of 2020".
4	SEC. 2. IMPROVING EMERGENCY UNEMPLOYMENT RELIEF
5	FOR GOVERNMENTAL ENTITIES AND NON-
6	PROFIT ORGANIZATIONS.
7	(a) IN GENERAL.—Section 903(i)(1) of the Social Se-
8	curity Act (42 U.S.C. 1103(i)(1)) is amended—
9	(1) in subparagraph (A), by striking "during"
10	and inserting "with respect to";
11	(2) in subparagraph (B), by striking
12	"3309(a)(1)" and inserting "3309(a)"; and
13	(3) by striking subparagraph (C) and inserting
14	the following new subparagraph:
15	"(C) Notwithstanding any other provision of law,
16	funds transferred to the account of a State under subpara-
17	graph (A) shall be used exclusively to reduce the amounts
18	required to be paid in lieu of contributions into the State
19	unemployment fund pursuant to such section by govern-
20	mental entities and other organizations described in sec-
21	tion 3309(a) of such Code.".
22	(b) Effective Date.—
23	(1) IN GENERAL.—Subject to paragraph (2),
24	the amendments made by subsection (a) shall take
25	effect as if included in the enactment of section
26	2103 of the Relief for Workers Affected by
