## AN ACT

To amend title 18, United States Code, to update the privacy protections for electronic communications information that is stored by third-party service providers in order to protect consumer privacy interests while meeting law enforcement needs, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Email Privacy Act”.

3 **SEC. 2. VOLUNTARY DISCLOSURE CORRECTIONS.**

4 (a) IN GENERAL.—Section 2702 of title 18, United  
5 States Code, is amended—

6 (1) in subsection (a)—

7 (A) in paragraph (1)—

8 (i) by striking “divulge” and inserting  
9 “disclose”; and

10 (ii) by striking “while in electronic  
11 storage by that service” and inserting  
12 “that is in electronic storage with or other-  
13 wise stored, held, or maintained by that  
14 service”;

15 (B) in paragraph (2)—

16 (i) by striking “to the public”;

17 (ii) by striking “divulge” and insert-  
18 ing “disclose”; and

19 (iii) by striking “which is carried or  
20 maintained on that service” and inserting  
21 “that is stored, held, or maintained by that  
22 service”; and

23 (C) in paragraph (3)—

24 (i) by striking “divulge” and inserting  
25 “disclose”; and

1 (ii) by striking “a provider of” and in-  
2 serting “a person or entity providing”;

3 (2) in subsection (b)—

4 (A) in the matter preceding paragraph (1),  
5 by inserting “wire or electronic” before “com-  
6 munication”;

7 (B) by amending paragraph (1) to read as  
8 follows:

9 “(1) to an originator, addressee, or intended re-  
10 cipient of such communication, to the subscriber or  
11 customer on whose behalf the provider stores, holds,  
12 or maintains such communication, or to an agent of  
13 such addressee, intended recipient, subscriber, or  
14 customer;”; and

15 (C) by amending paragraph (3) to read as  
16 follows:

17 “(3) with the lawful consent of the originator,  
18 addressee, or intended recipient of such communica-  
19 tion, or of the subscriber or customer on whose be-  
20 half the provider stores, holds, or maintains such  
21 communication;”;

22 (3) in subsection (c) by inserting “wire or elec-  
23 tronic” before “communications”;

24 (4) in each of subsections (b) and (c), by strik-  
25 ing “divulge” and inserting “disclose”; and

1           (5) in subsection (c), by amending paragraph  
2           (2) to read as follows:

3           “(2) with the lawful consent of the subscriber  
4           or customer;”.

5 **SEC. 3. AMENDMENTS TO REQUIRED DISCLOSURE SEC-**  
6 **TION.**

7           Section 2703 of title 18, United States Code, is  
8 amended—

9           (1) by striking subsections (a) through (c) and  
10          inserting the following:

11          “(a) CONTENTS OF WIRE OR ELECTRONIC COMMU-  
12          NICATIONS IN ELECTRONIC STORAGE.—Except as pro-  
13          vided in subsections (i) and (j), a governmental entity may  
14          require the disclosure by a provider of electronic commu-  
15          nication service of the contents of a wire or electronic com-  
16          munication that is in electronic storage with or otherwise  
17          stored, held, or maintained by that service only if the gov-  
18          ernmental entity obtains a warrant issued using the proce-  
19          dures described in the Federal Rules of Criminal Proce-  
20          dure (or, in the case of a State court, issued using State  
21          warrant procedures) that—

22                  “(1) is issued by a court of competent jurisdic-  
23          tion; and

1           “(2) may indicate the date by which the pro-  
2           vider must make the disclosure to the governmental  
3           entity.

4 In the absence of a date on the warrant indicating the  
5 date by which the provider must make disclosure to the  
6 governmental entity, the provider shall promptly respond  
7 to the warrant.

8           “(b) CONTENTS OF WIRE OR ELECTRONIC COMMU-  
9           NICATIONS IN A REMOTE COMPUTING SERVICE.—

10           “(1) IN GENERAL.—Except as provided in sub-  
11           sections (i) and (j), a governmental entity may re-  
12           quire the disclosure by a provider of remote com-  
13           puting service of the contents of a wire or electronic  
14           communication that is stored, held, or maintained by  
15           that service only if the governmental entity obtains  
16           a warrant issued using the procedures described in  
17           the Federal Rules of Criminal Procedure (or, in the  
18           case of a State court, issued using State warrant  
19           procedures) that—

20                   “(A) is issued by a court of competent ju-  
21                   risdiction; and

22                   “(B) may indicate the date by which the  
23                   provider must make the disclosure to the gov-  
24                   ernmental entity.

1 In the absence of a date on the warrant indicating  
2 the date by which the provider must make disclosure  
3 to the governmental entity, the provider shall  
4 promptly respond to the warrant.

5 “(2) APPLICABILITY.—Paragraph (1) is appli-  
6 cable with respect to any wire or electronic commu-  
7 nication that is stored, held, or maintained by the  
8 provider—

9 “(A) on behalf of, and received by means  
10 of electronic transmission from (or created by  
11 means of computer processing of communica-  
12 tion received by means of electronic trans-  
13 mission from), a subscriber or customer of such  
14 remote computing service; and

15 “(B) solely for the purpose of providing  
16 storage or computer processing services to such  
17 subscriber or customer, if the provider is not  
18 authorized to access the contents of any such  
19 communications for purposes of providing any  
20 services other than storage or computer proc-  
21 essing.

22 “(c) RECORDS CONCERNING ELECTRONIC COMMU-  
23 NICATION SERVICE OR REMOTE COMPUTING SERVICE.—

24 “(1) IN GENERAL.—Except as provided in sub-  
25 sections (i) and (j), a governmental entity may re-

1       quire the disclosure by a provider of electronic com-  
2       munication service or remote computing service of a  
3       record or other information pertaining to a sub-  
4       scriber to or customer of such service (not including  
5       the contents of wire or electronic communications),  
6       only—

7               “(A) if a governmental entity obtains a  
8       warrant issued using the procedures described  
9       in the Federal Rules of Criminal Procedure (or,  
10      in the case of a State court, issued using State  
11      warrant procedures) that—

12              “(i) is issued by a court of competent  
13      jurisdiction directing the disclosure; and

14              “(ii) may indicate the date by which  
15      the provider must make the disclosure to  
16      the governmental entity;

17              “(B) if a governmental entity obtains a  
18      court order directing the disclosure under sub-  
19      section (d);

20              “(C) with the lawful consent of the sub-  
21      scriber or customer; or

22              “(D) as otherwise authorized in paragraph  
23      (2).

24              “(2) SUBSCRIBER OR CUSTOMER INFORMA-  
25      TION.—A provider of electronic communication serv-

1 ice or remote computing service shall, in response to  
2 an administrative subpoena authorized by Federal or  
3 State statute, a grand jury, trial, or civil discovery  
4 subpoena, or any means available under paragraph  
5 (1), disclose to a governmental entity the—

6 “(A) name;

7 “(B) address;

8 “(C) local and long distance telephone con-  
9 nection records, or records of session times and  
10 durations;

11 “(D) length of service (including start  
12 date) and types of service used;

13 “(E) telephone or instrument number or  
14 other subscriber or customer number or iden-  
15 tity, including any temporarily assigned net-  
16 work address; and

17 “(F) means and source of payment for  
18 such service (including any credit card or bank  
19 account number),

20 of a subscriber or customer of such service.

21 “(3) NOTICE NOT REQUIRED.—A governmental  
22 entity that receives records or information under  
23 this subsection is not required to provide notice to  
24 a subscriber or customer.”;

25 (2) in subsection (d)—



1 (A) by striking “(b) or”;

2 (B) by striking “the contents of a wire or  
3 electronic communication, or”;

4 (C) by striking “sought,” and inserting  
5 “sought”; and

6 (D) by striking “section” and inserting  
7 “subsection”; and

8 (3) by adding at the end the following:

9 “(h) NOTICE.—Except as provided in section 2705,  
10 a provider of electronic communication service or remote  
11 computing service may notify a subscriber or customer of  
12 a receipt of a warrant, court order, subpoena, or request  
13 under subsection (a), (b), (c), or (d) of this section.

14 “(i) RULE OF CONSTRUCTION RELATED TO LEGAL  
15 PROCESS.—Nothing in this section or in section 2702  
16 shall limit the authority of a governmental entity to use  
17 an administrative subpoena authorized by Federal or  
18 State statute, a grand jury, trial, or civil discovery sub-  
19 poena, or a warrant issued using the procedures described  
20 in the Federal Rules of Criminal Procedure (or, in the  
21 case of a State court, issued using State warrant proce-  
22 dures) by a court of competent jurisdiction to—

23 “(1) require an originator, addressee, or in-  
24 tended recipient of a wire or electronic communica-  
25 tion to disclose a wire or electronic communication

1 (including the contents of that communication) to  
2 the governmental entity;

3 “(2) require a person or entity that provides an  
4 electronic communication service to the officers, di-  
5 rectors, employees, or agents of the person or entity  
6 (for the purpose of carrying out their duties) to dis-  
7 close a wire or electronic communication (including  
8 the contents of that communication) to or from the  
9 person or entity itself or to or from an officer, direc-  
10 tor, employee, or agent of the entity to a govern-  
11 mental entity, if the wire or electronic communica-  
12 tion is stored, held, or maintained on an electronic  
13 communications system owned, operated, or con-  
14 trolled by the person or entity; or

15 “(3) require a person or entity that provides a  
16 remote computing service or electronic communica-  
17 tion service to disclose a wire or electronic commu-  
18 nication (including the contents of that communica-  
19 tion) that advertises or promotes a product or serv-  
20 ice and that has been made readily accessible to the  
21 general public.

22 “(j) RULE OF CONSTRUCTION RELATED TO CON-  
23 GRESSIONAL SUBPOENAS.—Nothing in this section or in  
24 section 2702 shall limit the power of inquiry vested in the  
25 Congress by article I of the Constitution of the United

1 States, including the authority to compel the production  
2 of a wire or electronic communication (including the con-  
3 tents of a wire or electronic communication) that is stored,  
4 held, or maintained by a person or entity that provides  
5 remote computing service or electronic communication  
6 service.”.

7 **SEC. 4. DELAYED NOTICE.**

8 Section 2705 of title 18, United States Code, is  
9 amended to read as follows:

10 **“§ 2705. Delayed notice**

11 “(a) IN GENERAL.—A governmental entity acting  
12 under section 2703 may apply to a court for an order di-  
13 recting a provider of electronic communication service or  
14 remote computing service to which a warrant, order, sub-  
15 poena, or other directive under section 2703 is directed  
16 not to notify any other person of the existence of the war-  
17 rant, order, subpoena, or other directive.

18 “(b) DETERMINATION.—A court shall grant a re-  
19 quest for an order made under subsection (a) for delayed  
20 notification of up to 180 days if the court determines that  
21 there is reason to believe that notification of the existence  
22 of the warrant, order, subpoena, or other directive will  
23 likely result in—

24 “(1) endangering the life or physical safety of  
25 an individual;

- 1           “(2) flight from prosecution;
- 2           “(3) destruction of or tampering with evidence;
- 3           “(4) intimidation of potential witnesses; or
- 4           “(5) otherwise seriously jeopardizing an inves-
- 5           tigation or unduly delaying a trial.

6           “(c) EXTENSION.—Upon request by a governmental

7           entity, a court may grant one or more extensions, for peri-

8           ods of up to 180 days each, of an order granted in accord-

9           ance with subsection (b).”.

10 **SEC. 5. RULE OF CONSTRUCTION.**

11           Nothing in this Act or an amendment made by this

12           Act shall be construed to preclude the acquisition by the

13           United States Government of—

14           (1) the contents of a wire or electronic commu-

15           nication pursuant to other lawful authorities, includ-

16           ing the authorities under chapter 119 of title 18

17           (commonly known as the “Wiretap Act”), the For-

18           eign Intelligence Surveillance Act of 1978 (50

19           U.S.C. 1801 et seq.), or any other provision of Fed-

20           eral law not specifically amended by this Act; or

21           (2) records or other information relating to a

22           subscriber or customer of any electronic communica-

23           tion service or remote computing service (not includ-

24           ing the content of such communications) pursuant to

25           the Foreign Intelligence Surveillance Act of 1978

1 (50 U.S.C. 1801 et seq.), chapter 119 of title 18  
2 (commonly known as the “Wiretap Act”), or any  
3 other provision of Federal law not specifically  
4 amended by this Act.
