A BILL

To reform the Federal Insurance Office of the Department
of the Treasury, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Federal Insurance Office*
5 *Reform Act of 2018”.*

6 **SEC. 2. REFORM OF FEDERAL INSURANCE OFFICE.**

7 (a) *IN GENERAL.*—Section 313 of title 31, United
8 *States Code, is amended as follows:*

9 (1) *LEADERSHIP.*—*In the first sentence of sub-*
10 *section (b), by inserting before the period at the end*
11 *the following: “after consultation with State insur-*
12 *ance commissioners”.*

13 (2) *FUNCTIONS.*—*In subsection (c)(1)—*

14 (A) *in subparagraph (E), by striking “to*
15 *coordinate” and all that follows through “United*
16 *States” and inserting the following: “to coordi-*
17 *nate Federal efforts, and to coordinate with the*
18 *States, in developing Federal policy on pruden-*
19 *tial aspects of international insurance matters,*
20 *including representing the Federal Government”;*

21 (B) *in subparagraph (F), by striking “to*
22 *determine” and inserting “to assist the Secretary*
23 *in determining”;* and

24 (C) *by striking subparagraph (G) and in-*
25 *serting the following:*

1 “(G) to consult and work toward consensus
2 with the States (including State insurance regu-
3 lators) on matters of international importance;
4 and”.

5 (3) *GATHERING OF INFORMATION.*—In subsection
6 (e)—

7 (A) in paragraph (1)—

8 (i) in the matter preceding subpara-
9 graph (A), by striking “may—” and insert-
10 ing “may enter into information-sharing
11 agreements.”; and

12 (ii) by striking subparagraphs (A)
13 through (D);

14 (B) by striking paragraphs (2), (3), (4),
15 and (6); and

16 (C) by redesignating paragraph (5) as
17 paragraph (2).

18 (4) *PREEMPTION OF STATE INSURANCE MEAS-*
19 *URES.*—In subsection (f), by striking “Director” each
20 place such term appears and inserting “Secretary”.

21 (5) *CONSULTATION.*—In subsection (i)—

22 (A) by striking “to the extent the Director
23 determines appropriate,”; and

24 (B) by inserting before the period at the end
25 the following: “and shall seek to include in such

1 *meetings, State insurance commissioners, or at*
2 *the option of the State insurance commissioners,*
3 *designees acting at the direction of the State in-*
4 *urance commissioners, throughout the negotia-*
5 *tions of a covered agreement”.*

6 (6) *RETENTION OF EXISTING STATE REGU-*
7 *LATORY AUTHORITY.—In subsection (k), by inserting*
8 *before the period at the end the following: “or with the*
9 *authority to participate in a supervisory college or*
10 *similar regulatory process”.*

11 (7) *REPEAL OF CERTAIN REPORTS REQUIRE-*
12 *MENTS.—By striking subsections (o) and (p) and re-*
13 *designating subsections (q) through (s) as subsections*
14 *(o) through (q), respectively.*

15 (8) *DEFINITION.—In subsection (p)(2), as so re-*
16 *designated by paragraph (7)—*

17 (A) *in subparagraph (A), by striking “and”*
18 *at the end;*

19 (B) *in subparagraph (B), by striking the*
20 *period at the end and inserting “; and”; and*

21 (C) *by adding at the end the following new*
22 *subparagraph:*

23 *“(C) does not include new prudential re-*
24 *quirements for United States insurers.”.*

1 **(b) CONFORMING AMENDMENT.**—*Subparagraph (E) of*
2 *section 313(c)(1) of title 31, United States Code, is amended*
3 *by striking “subsection (r)” and inserting “subsection (p)”.*

4 **SEC. 3. TREATMENT OF TERRORISM RISK INSURANCE ACT.**

5 *This Act and the amendments made by this Act may*
6 *not be construed to affect any responsibilities, duties, or au-*
7 *thorities of the Secretary of the Treasury under the Ter-*
8 *rorism Risk Insurance Act of 2002 (15 U.S.C. 6701 note).*
