2 (e) (1) Except as provided in paragraph (2) of this subsection or § 3 10–512(a)(2)(ii) of this title, a person may not sell, offer for sale, barter, or exchange, at any 4 time within the State any game bird or game mammal taken from the wild, in the State or 5 in another state, territory, or country.

(2) The prohibitions of paragraph (1) of this subsection do not apply to the:

(i) Meat, pelt, carcass, or mounted specimen of any beaver, coyote,
fisher, fox, mink, muskrat, nutria, opossum, otter, raccoon, skunk, or long-tailed weasel
legally taken by the person;

10 (ii) Hide, hair, tail, or feet, excluding a mounted specimen of deer, 11 squirrel, or rabbit legally acquired;

12 (iii) Feathers, skin, or feet, excluding a mounted specimen of upland 13 and forest game birds legally acquired;

14 (iv) Except as prohibited by federal law, feathers of wetland game 15 birds legally acquired; [or]

16 (v) Antlers of deer legally acquired in another state and 17 manufactured into an article of commerce in another state; **OR** 

(VI) LEGALLY ACQUIRED MOUNTED SPECIMEN OF A GAME BIRD,
EXCLUDING A MIGRATORY GAME BIRD, OR GAME MAMMAL, IF THE ORIGINAL OWNER
IS DECEASED AND THE SPECIMEN IS PART OF THE PERSONAL PROPERTY OF AN
OWNER WHOSE ESTATE IS BEING LIQUIDATED OR DISTRIBUTED.

(g) Except as authorized under Subtitle 5 or Subtitle 9 of this title, a person may not purchase, offer to purchase, barter, or exchange any game bird or game mammal or any part of a game bird or game mammal if the sale, offer for sale, barter, or exchange is prohibited by this section.
