 - **3** SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as the "Retired Military Mem-
 - 5 ber Appointments to the Department of Defense Act".

1 SEC. 2. MODIFICATION OF PERIOD AFTER RETIREMENT

2	FOR AUTHORITY OF DEPARTMENT OF DE-
3	FENSE TO APPOINT RETIRED MEMBERS OF
4	THE ARMED FORCES TO POSITIONS WITHIN
5	THE DEPARTMENT AFTER RETIREMENT.
6	Section 3326 of title 5, United States Code, is
7	amended—
8	(1) by striking subsection (b) and inserting the
9	following:
10	((b)(1) A retired member of the armed forces may
11	be appointed to a position in the civil service in or under
12	the Department of Defense (including a nonappropriated
13	fund instrumentality under the jurisdiction of the armed
14	forces) immediately after the retirement of the member
15	only if the proposed appointment is authorized by the Sec-
16	retary concerned or a designee of the Secretary concerned,
17	after a determination that—
18	"(A) the position has not been held open pend-
19	ing the retirement of the retired member;
20	"(B) qualification requirements for the position
21	have not been written in a manner designed to give
22	advantage to the retired member; and
23	"(C) the retired member was considered and se-
24	lected in accordance with the applicable law (includ-
25	ing regulations) governing the appointing authority
26	used to appoint the retired member.

1 "(2) The Secretary concerned or a designee of the 2 Secretary concerned shall determine the duration under which the provisions of this subsection apply."; and 3 4 (2) by adding at the end the following: 5 "(d)(1) Not later than February 15 each year, the 6 Secretary of Defense and the Director of the Office of Per-7 sonnel Management shall jointly submit to Congress a re-8 port on the appointments made during the preceding year 9 using the authority in subsection (b)(1). 10 "(2) Each report under this subsection shall set 11 forth, for the year covered by such report, the following: "(A) The number of appointments made using 12 13 the authority in subsection (b)(1). 14 "(B) The grades at retirement from the armed 15 forces of the individuals subject to such appoint-16 ments. 17 "(C) The job titles, pay grades, and locations of

18 employment at appointment of the individuals sub-19 ject to such appointments.".
