## A BILL

To amend the Public Works and Economic Development Act of 1965 to provide for the release of certain Federal interests in connection with certain grants under that Act, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Reinvigorating Lend-  
5 ing for the Future Act” or the “RLF Act”.

1 **SEC. 2. RELEASE OF CERTAIN INTERESTS.**

2 Section 601(d)(2) of the Public Works and Economic  
3 Development Act of 1965 (42 U.S.C. 3211(d)(2)) is  
4 amended—

5 (1) by striking the paragraph designation and  
6 heading and all that follows through “The Secretary  
7 may” and inserting the following:

8 “(2) RELEASE.—

9 “(A) IN GENERAL.—Except as provided in  
10 subparagraph (B), the Secretary may”; and

11 (2) by adding at the end the following:

12 “(B) CERTAIN RELEASES.—

13 “(i) IN GENERAL.—On written re-  
14 quest from a recipient of a grant under  
15 section 209(d), the Secretary shall release,  
16 in accordance with this subparagraph, any  
17 Federal interest in connection with the  
18 grant, if—

19 “(I) the request is made not less  
20 than 7 years after the final disburse-  
21 ment of the original grant;

22 “(II) the recipient has complied  
23 with the terms and conditions of the  
24 grant to the satisfaction of the Sec-  
25 retary;

1 “(III) any proceeds realized from  
2 the grant will be used for one or more  
3 activities that continue to carry out  
4 the economic development purposes of  
5 this Act; and

6 “(IV) the recipient includes in  
7 the written request a description of  
8 how the recipient will use the proceeds  
9 of the grant in accordance with sub-  
10 clause (III).

11 “(ii) DEADLINE.—

12 “(I) IN GENERAL.—Except as  
13 provided in subclause (II), the Sec-  
14 retary shall complete all closeout ac-  
15 tions for the grant by not later than  
16 180 days after receipt and acceptance  
17 of the written request under clause  
18 (i).

19 “(II) EXTENSION.—The Sec-  
20 retary may extend a deadline under  
21 subclause (I) by an additional 180  
22 days if the Secretary determines the  
23 extension to be necessary.

24 “(iii) SAVINGS PROVISION.—Section  
25 602 shall continue to apply to a project as-

1                   sisted with a grant under section 209(d)  
2                   regardless of whether the Secretary re-  
3                   leases a Federal interest under clause (i).”.
