6	(a) EXTENSION.—Subsection (b) of section 506 of
7	the Caregivers and Veterans Omnibus Health Services Act

8 of 2010 (Public Law 111–163; 38 U.S.C. 523 note) is9 amended to read as follows:

10 "(b) DURATION OF PROGRAM.—The Secretary may
11 not carry out the pilot program after September 30,
12 2019.".

(b) EXPANSION OF LOCATIONS.—Subsection (c) of
such section is amended by adding at the end the following
new paragraph:

"(3) ADDITIONAL LOCATIONS.—The Secretary
may expand the pilot program to include additional
locations if the Secretary recommends that the pilot
program be expanded in the initial report submitted
under subsection (g)(2)(C).".

21 (c) REPORT.—Subsection (g) of such section is 22 amended—

(1) in the subsection heading, by striking "REPORT ON PROGRAM" and inserting "REPORTS";

(2) in paragraph (1), by inserting "and not 1 2 later than 180 days after the completion of the pilot program," after "September 30, 2017,"; and 3 4 (3) in paragraph (2)— 5 (A) in the matter preceding subparagraph (A), by striking "The report" and inserting 6 "Each report"; and 7 (B) in subparagraph (C), by inserting "or 8 expanding" after "continuing". 9
