## A BILL

To amend the Federal Water Pollution Control Act and direct the Secretary of the Interior to conduct a study with respect to stormwater runoff from oil and gas operations, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2       This Act may be cited as the “Focused Reduction of  
3 Effluence and Stormwater runoff through Hydrofracking  
4 Environmental Regulation Act of 2017” or the “FRESH-  
5 ER Act of 2017”.

6 **SEC. 2. STORMWATER RUNOFF FROM OIL, GAS, AND MIN-**  
7 **ING OPERATIONS.**

8       (a) **LIMITATION ON PERMIT REQUIREMENT.**—Sec-  
9 tion 402(l) of the Federal Water Pollution Control Act (33  
10 U.S.C. 1342) is amended by striking paragraph (2) and  
11 redesignating paragraph (3) as paragraph (2).

12       (b) **DEFINITIONS.**—Section 502 of the Federal Water  
13 Pollution Control Act (33 U.S.C. 1362) is amended—

14               (1) by striking paragraph (24); and

15               (2) by redesignating paragraphs (25) and (26)  
16 as paragraphs (24) and (25), respectively.

17       (c) **STUDY.**—

18               (1) **IN GENERAL.**—The Secretary of the Inte-  
19 rior shall conduct a study of stormwater impacts  
20 with respect to any area that the Secretary deter-  
21 mines may be contaminated by stormwater runoff  
22 associated with oil or gas operations, which shall in-  
23 clude—

24                       (A) an analysis of measurable contamina-  
25 tion in such area;

1           (B) an analysis of ground water resources  
2           in such area; and

3           (C) an analysis of the susceptibility of  
4           aquifers in such area to contamination from  
5           stormwater runoff associated with such oper-  
6           ations.

7           (2) REPORT.—Not later than 1 year after the  
8           date of enactment of this section, the Secretary shall  
9           submit to Congress a report on the results of studies  
10          conducted under paragraph (1).
