# H. R. 5809

To amend title XXVII of the Public Health Service Act, the Internal Revenue Code of 1986, and the Employee Retirement Income Security Act of 1974 to require group health plans and health insurance issuers to include certain information on any health insurance membership card issued by such plan or issuer.

# A BILL

To amend title XXVII of the Public Health Service Act, the Internal Revenue Code of 1986, and the Employee Retirement Income Security Act of 1974 to require group health plans and health insurance issuers to include certain information on any health insurance membership card issued by such plan or issuer.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

#### SECTION 1. SHORT TITLE.

2	This Act may be cited as the "Better Information Act
3	of 2020".

- 9 the end the following new section:
- 10 "SEC. 2730. INFORMATION REQUIRED TO BE INCLUDED ON
- 11 HEALTH INSURANCE MEMBERSHIP CARDS.
- "In the case of a group health plan or health insur-
- 13 ance issuer offering group or individual health insurance
- 14 coverage that provides a physical or electronic card indi-
- 15 cating membership in such plan or coverage to an indi-
- 16 vidual enrolled under such plan or coverage, such group
- 17 health plan or issuer shall include on such card each of
- 18 the following:
- 19 "(1) The nearest hospital to the primary resi-
- dence of such individual that has in effect a contrac-
- tual relationship with such plan or coverage for fur-
- 22 nishing items and services under such plan or cov-
- erage.
- 24 "(2) A telephone number or Internet website
- address through which such individual may seek con-
- sumer assistance information, such as information

- related to hospitals and urgent care facilities that
  have in effect a contractual relationship with such
  plan or coverage for furnishing items and services
  under such plan or coverage.
- 5 "(3) Any deductible applicable to such indi-6 vidual.
- 7 "(4) Any out-of-pocket maximum applicable to 8 such individual.
  - "(5) Any cost-sharing obligation applicable to such individual for a visit at an emergency department, or urgent care facility, that has in effect a contractual relationship with such plan or coverage for furnishing items and services under such plan or coverage.".

#### (b) Internal Revenue Code.—
