# A BILL

To extend authorization for the September 11th Victim Compensation Fund of 2001 through fiscal year 2090, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

#### 1 SECTION 1. SHORT TITLE.

- This Act may be cited as the "Never Forget the He-
- 3 roes: Permanent Authorization of the September 11th Vic-
- 4 tim Compensation Fund Act".
- 5 SEC. 2. SEPTEMBER 11TH VICTIM COMPENSATION FUND OF
- 6 2001.
- 7 (a) Authorization and Funding.—Section 410 of
- 8 the Air Transportation Safety and System Stabilization
- 9 Act (49 U.S.C. 40101 note) is amended—
- 10 (1) in subsection (c), by striking
- 11 "\$4,600,000,000" and all that follows through "ex-
- pended" and inserting "such sums as may be nec-
- essary for fiscal year 2019 and each fiscal year
- thereafter through fiscal year 2090, to remain avail-
- able through such fiscal year"; and
- 16 (2) in subsection (e), by striking "Upon comple-
- tion of all payments under this title" and inserting
- 18 "On October 1, 2090".
- 19 (b) Extending Filing Deadline.—Section
- 20 405(a)(3)(B) of the Air Transportation Safety and Sys-
- 21 tem Stabilization Act (49 U.S.C. 40101 note) is amended
- 22 by striking "the date that is 5 years after the date of en-
- 23 actment of the James Zadroga 9/11 Victim Compensation
- 24 Fund Reauthorization Act" and inserting "October 1,
- 25 2089".
