4 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. The following amendment to the Constitution of Alabama of 1901, is proposed and shall become valid as a part of the Constitution when all requirements of this act are fulfilled:

PROPOSED AMENDMENT

- (a) This amendment shall apply only in Tuscaloosa County.
- (b) Any privately owned plant, property, or facility used for the collection, treatment, or disposal of sewage that uses, directly or through a lease or contract, public rights-of-way of public roads for any part of its collection or disposal system and that has residential or commercial customers located in the city limits of Lake View in Tuscaloosa County that are billed a flat service fee or fee based on water usage shall be certified and regulated by the Public Service Commission in relation to all of the customers of the entity located in the city limits of Lake View and in the unincorporated areas of Tuscaloosa County.

Section 2. An election upon the proposed amendment shall be held in accordance with Sections 284 and 284.01 of the Constitution of Alabama of 1901, now appearing as Sections 284 and 284.01 of the Official Recompilation of the

1	Constitution of Alabama of 1901, as amended, and the election
2	laws of this state.
3	Section 3. The appropriate election official shall
4	assign a ballot number for the proposed constitutional
5	amendment on the election ballot and shall set forth the
6	following description of the substance or subject matter of
7	the proposed constitutional amendment:
8	"Relating to Tuscaloosa County, proposing an
9	amendment to the Constitution of Alabama of 1901, to bring
10	certain privately owned sewer systems that use public
11	rights-of-way of public roads in the city limits of Lake View
12	under the jurisdiction of the Public Service Commission.
13	"Proposed by Act"
14	This description shall be followed by the following
15	language:
