- 8 (1) develop and make available a resource directory of mental health and 9 substance use disorder providers' inventory that:
- 10(i)tracks inventory of services by type, location, and organization;11and
- 12 (ii) is available to the public;

13 (2) develop a registry and referral system pilot program in at least two 14 jurisdictions in the State to assess the feasibility and necessity of mandating all inpatient 15 and outpatient mental health and substance use disorder providers to update registry 16 information in real time; and

17 (3) develop a plan for funding the statewide expansion of the Maryland 18 Mental Health and Substance Use Disorder Registry and Referral System established 19 under § 7.5–802 of the Health – General Article, as enacted by Section 1 of this Act, and 20 ongoing operations of the Registry and Referral System; and

21 (3) (4) report to the Senate Finance Committee and the House Health and
 22 Government Operations Committee, in accordance with § 2–1257 of the State Government
 23 Article, on:

- 24 (i) the development of the resource directory required under item 25 (1) of this section; and
- 26 (ii) the development of the pilot program required under item (2) of
 27 this section; and
- (iii) recommendations for enforcement mechanisms to be applied to
 providers who are mandated to use the Maryland Mental Health and Substance Use
 Disorder Registry and Referral System established under § 7.5–802 of the Health General
 Article, as enacted by Section 1 of this Act.
