If that termination provision takes effect, 12 Section 1 of this Act, with no further action required by the General Assembly, shall be 13 abrogated and of no further force and effect. This Act may not be interpreted to have any 14 effect on that termination provision.

15 SECTION 5. AND BE IT FURTHER ENACTED, That, subject to the provisions of 16 Section 4 of this Act, this Act shall take effect July 1, 2020.
