1 AN ACT concerning

Maryland Boat Act – Abandoned and Sunken Vessels

- FOR the purpose of altering the definition of "abandoned or sunken vessel" for purposes of
 certain provisions of the Maryland Boat Act to include a vessel that has remained
 moored or anchored in waters of the State for more than a certain number of days
 and is in such a condition of disrepair that the vessel will not keep afloat with
 ordinary care; and generally relating to abandoned and sunken vessels.

- 18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 19 That the Laws of Maryland read as follows:

2 (c) (1) No later than 15 days before an abandoned or sunken vessel is seized, 3 removed, or taken into custody under subsection (b) of this section, the Department shall 4 send a notice, by certified mail, return receipt requested, bearing a postmark from the 5 United States Postal Service to the last known registered owner of the vessel, as shown on 6 the records of the Department.

7 (2) As soon as reasonably possible but not later than 15 days after the 8 Department takes an abandoned or sunken vessel into custody, the Department shall send 9 a notice, by certified mail, return receipt requested, bearing a postmark from the United 10 States Postal Service to the last known registered owner of the vessel and to each secured 11 party, as shown on the records of the Department.

- 12 (d) The notices required by subsection (c) of this section shall:
- 13 (1) Describe the vessel;

14 (2) Give the location where the vessel is being held;

15 (3) Inform the owner and secured party of a right to reclaim the vessel 16 within 3 weeks of receipt of the notice required in subsection (c)(2) of this section upon 17 payment to the Department of any expenses incurred during removal and custody of the 18 vessel; and

(ii) A consent to the Department's disposition of the vessel.

A waiver of all right, title, and interest in the vessel; and

(e) (1) If the Department is unable to determine the last registered owner or the identity of any secured party of the abandoned or sunken vessel, or if the certified mail notice required under subsection (c) of this section is returned as undeliverable, the Department shall give the required notice by publication in at least 1 newspaper of general circulation in the area where the abandoned or sunken vessel was found.

27 (2) The notice by publication shall contain the information required under 28 subsection (d) of this section and shall be published within 30 days of the seizure of the 29 abandoned or sunken vessel, or within 15 days of the return of the certified mail notice as 30 undeliverable.

(f) If the owner or secured party fails to claim the abandoned or sunken vessel within 3 weeks after the certified mail notice or after the notice by publication is given, the Department may sell the vessel at public auction, proceed to receive title to the vessel pursuant to § 8–722 of this subtitle, or otherwise dispose of the vessel.

1 (g) If the abandoned or sunken vessel is in such a condition of disrepair that the 2 Department cannot remove the vessel intact, the Department may dispose of the vessel in 3 whatever manner is reasonable without providing the notice required under subsections (c) 4 through (e) of this section.

5 (h) The Department may delegate the Department's authority to remove and 6 dispose of abandoned or sunken vessels under this section to any local jurisdiction that 7 consents to the delegation.

8 (i) The Department, in consultation with the Director of the Maryland Historical 9 Trust, may adopt regulations to implement this section.

11 (a) A person may not abandon, as defined in § 8–721 of this subtitle, any vessel 12 upon any waters of the State.

13 (b) The last known registered owner shown on the certificate of title issued under
14 § 8–715 of this subtitle shall be considered:

15(1)The prima facie owner of a vessel at the time the vessel was abandoned;16and

17 (2) The person who abandoned the vessel.

18 (c) (1) Any person who violates any provision of this section is guilty of a 19 misdemeanor. Upon conviction, the person is subject to a fine not exceeding \$1,000 or 20 imprisonment not exceeding 6 months, or both.

21 (2) Any person found guilty of a second or subsequent violation of any 22 provision of this section is subject to a fine not exceeding \$2,000 or imprisonment not 23 exceeding 1 year, or both.

24 (3) Any person who violates any provision of this section is liable to the25 State for the cost of removal of the vessel.

26 (4) The provisions of this section do not apply to a vessel wrecked through 27 an act of God or negligence of a third party.

28 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 29 October 1, 2020.
