BY repealing and reenacting, with amendments, Article – Human Services Section 5-5A-08 Annotated Code of Maryland (2019 Replacement Volume and 2020 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article - Human Services 5-5A-08. (a) In this section the following words have the meanings indicated. (1)

- 1 (2) "CMN Program" means the Critical Medical Needs Program 2 established under this section.

  3 (3) "Critical medically vulnerable individual" means an individual who:
  - (i) has a severe health condition that will be aggravated due to the termination or noncontinuation of electric or gas service or needs the use of life—support equipment as documented and certified in accordance with regulations on a certification of serious illness or life support form submitted to the appropriate electric or gas company;
- $8 \hspace{1.5cm} \mbox{(ii)} \hspace{0.5cm} \mbox{has or will have their electric or gas service terminated for 9 nonpayment; and$
- 10 (iii) is unable to complete the energy assistance applications under 11 available energy assistance programs, including energy efficiency programs offered by the 12 Department of Housing and Community Development.
- 13 (4) "Navigator" means a representative from a medical facility or from a 14 public or private assistance agency or organization who:
- 15 (i) is in personal contact with a critical medically vulnerable 16 individual; and
- 17 (ii) assists the critical medically vulnerable individual in the energy 18 assistance application process.
- 19 (b) (1) There is a CMN Program in the Office.
- 20 (2) The Office shall implement and administer the CMN Program.
- 21 (3) In administering the CMN Program, the Office shall partner with the 22 Office of People's Counsel, the Fuel Fund of Central Maryland, the Cancer Support 23 Foundation, electric and gas companies, nonprofit organizations, other State agencies, the 24 health care community, and any other organization that the Office determines appropriate.
- 25 (4) The purpose of the CMN Program is to reduce the barriers to the energy 26 assistance application process for critical medically vulnerable individuals and their 27 households in obtaining State and federal financial assistance for their electric, gas, or other energy source bills so that their electric, gas, or other energy source service continues 29 or is restored.
- 30 (c) (1) The CMN Program shall facilitate assistance to critical medically 31 vulnerable individuals and their households in obtaining State and federal financial 32 assistance for their electric, gas, or other source energy bills through navigators.
- 33 (2) The Office shall determine qualifications and establish training 34 requirements for navigators.

$\frac{1}{2}$	(3) The Office shall train navigators or facilitate the training of navigators by others.
3 4 5	(d) In accordance with the requirements set forth in the Code of Maryland Regulations, the Office shall work with electric and gas companies to implement, for critical medically vulnerable individuals:
6 7 8	(1) a medical hold on electric or gas service or an expedited process to grant the extension of electric or gas service for those who will have their electric or gas services terminated; and
9 10	(2) an expedited process for the restoration of electric or gas service for those who have had their electric or gas service terminated.
11 12 13 14 15	(e) If a critical medically vulnerable individual is at least 60 years old and assisted by a navigator when applying to participate in the CMN Program, the Office may not require shall allow the individual 90 days after applying for assistance to provide certification from a medical provider of the severe health condition.
16 17	<b>(F)</b> The Office shall establish a tracking system of the status of critical medically vulnerable individuals who participate in the CMN Program.
18	[(f)] (G) The Department shall adopt regulations to implement this section.
19 20	SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June 1, 2021.
