# A BILL

- To authorize the Director of the National Institutes of Health to establish prize competitions to incentivize research by institutions of higher education on at-home testing for the detection of current infection with the virus that causes COVID-19, and for other purposes.

  - 2 tives of the United States of America in Congress assembled,

### **3** SECTION 1. SHORT TITLE.

4 This Act may be cited as the "At-Home Testing Prize

5 Competitions Act of 2020".

## 1 SEC. 2. FINDINGS.

2	Congress finds the following:
3	(1) Prize competitions have been used through-
4	out America's history, dating back to the designing
5	of the United States Capitol Building in 1792.
6	(2) The America COMPETES Reauthorization
7	Act of 2010 granted authority for Federal agencies
8	to carry out prize competitions in order to stimulate
9	innovation to advance each agency's mission.
10	(3) Prize competitions provide a benefit to the
11	American people by providing a high reward return
12	on taxpayer dollars.
13	(4) Since 2010, Federal agencies have con-
14	ducted nearly 1,000 prize competitions to help ad-
15	dress some of our Nation's greatest challenges.
16	(5) In order to mitigate the spread of COVID–
17	19, Americans needs access to rapid diagnostic test-
18	ing in their homes.
19	(6) At-home infectious disease tests provide re-
20	sults in real time, rather than in hours or days.
21	(7) Infectious disease tests are useful in re-
22	source-limited situations where there may not be ac-
23	cess to a central laboratory or where infrastructure
24	is limited for transporting samples. At-home infec-
25	tious disease tests can also lead to prompter treat-
26	ment, which can prevent infections from spreading.

1 (8) Although other Federal agencies are cur-2 rently involved in supporting and conducting re-3 search into at-home testing, research spurred by 4 prize competitions at the National Institutes of 5 Health in consultation with the National Institute of 6 Standards and Technology can have broader benefits 7 for the American public. 8 (9) The National Institute of Standards and 9 Technology, due to its expertise in materials meas-10 urement, including for DNA and other biological 11 materials, is well positioned to support the National 12 Institutes of Health in the development of reference 13 materials and best practices for the assessment and 14 validation of COVID-19 test results. 15 SEC. 3. ESTABLISHMENT OF PRIZE COMPETITION FOR RE-16 SEARCH ON COVID-19 AT-HOME TESTING. 17 (a) IN GENERAL.—The Director of the National In-18 stitutes of Health, in consultation with the Director of the National Institute of Standards and Technology, shall 19 20 carry out prize competitions pursuant to section 24 of the 21 Stevenson-Wydler Technology Innovation Act of 1980 (15) U.S.C. 3719) to incentivize research by institutions of 22 23 higher education on at-home testing for the detection of 24 current infection with the virus that causes COVID-19.

(b) REQUIREMENTS.—To be eligible for funding
 under this section, the at-home testing subject to the pro posed research must be capable of—

- 4 (1) being self-administered; and
- 5 (2) producing results in 30 minutes or less.

6 (c) TIMING.—The Director of the National Institutes
7 of Health shall—

8 (1) publicize at least one prize competition pur9 suant to subsection (a) within 30 days after the date
10 of enactment of this Act; and

(2) publicize additional prize competitions pursuant to subsection (a) as determined appropriate by
the Director.

(d) NIST ASSISTANCE.—The Director of the National Institute of Standards and Technology shall provide
assistance to the Director of the National Institutes of
Health on developing validation protocols and standards
for testing developed pursuant to this section.
