## A BILL

To extend the protections of the Fair Housing Act to persons suffering discrimination on the basis of sex or sexual orientation, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Fair and Equal Hous-
- 5 ing Act of 2017".
- 6 SEC. 2. HOUSING.
- 7 (a) Fair Housing Act.—The Fair Housing Act (42
- 8 U.S.C. 3601 et seq.) is amended—

1 (1) in section 802, by adding at the end the fol-2 lowing: 3 "(p) 'Race', 'color', 'religion', 'sex', 'sexual orientation', 'gender identity', 'handicap', 'familial status', or 'na-5 tional origin', used with respect to an individual, in-6 cludes— "(1) the race, color, religion, sex, sexual ori-7 8 entation, gender identity, handicap, familial status, 9 or national origin, respectively, of another person 10 with whom the individual is associated or has been 11 associated; and "(2) a perception or belief, even if inaccurate, 12 13 concerning the race, color, religion, sex, sexual ori-14 entation, gender identity, handicap, familial status, 15 or national origin, respectively, of the individual. "(q) 'Gender identity' means the gender-related iden-16 tity, appearance, or mannerisms or other gender-related characteristics of an individual, without regard to the indi-18 vidual's designated sex at birth. 19 "(r) 'Sexual orientation' means homosexuality, het-20 21 erosexuality, or bisexuality."; (2) in section 804, by inserting "sexual orienta-22 tion, gender identity" after "sex," each place that 23 24 term appears;

1	(3) in section 805, by inserting "sexual orienta-
2	tion, gender identity" after "sex," each place that
3	term appears;
4	(4) in section 806, by inserting "sexual orienta-
5	tion, gender identity" after "sex," each place that
6	term appears;
7	(5) in section 808(e)(6), by inserting "sexual
8	orientation, gender identity" after "sex,"; and
9	(6) by adding at the end the following:".
10	(b) Prevention of Intimidation in Fair Hous-
11	ING CASES.—Section 901 of the Civil Rights Act of 1968
12	(42 U.S.C. 3631) is amended by inserting "gender iden-
13	tity, sexual orientation (as such term is defined in section
14	802 of this Act)," after "sex," each place that term ap-
15	pears.
