A BILL

To amend the Help America Vote Act of 2002 to allow the use of requirements payments to conduct a post-election audit with respect to an election for Federal office in a State.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Federal Election Audit*
5 *Act”.*

6 **SEC. 2. USE OF REQUIREMENTS PAYMENTS FOR POST-**
7 **ELECTION AUDITS.**

8 *(a) PERMITTING USE OF PAYMENTS FOR AUDITS.—*
9 *Section 251(b)(1) of the Help America Vote Act of 2002 (52*
10 *U.S.C. 21001(b)(1)) is amended by inserting “, including*
11 *to conduct and publish an audit of the effectiveness and*
12 *accuracy of the voting systems, nonvoting election tech-*
13 *nology (as defined in paragraph (4)(B)), election proce-*
14 *dures, and outcomes used to carry out an election for Fed-*
15 *eral office in the State and the performance of the State*
16 *and local election officials who carried out the election, but*
17 *only if the audit meets the requirements of paragraph*
18 *(4)(A)” after “requirements of title III”.*

19 *(b) REQUIREMENTS FOR AUDITS; NONVOTING ELEC-*
20 *TION TECHNOLOGY DEFINED.—Section 251(b) of such Act*
21 *(52 U.S.C. 21001(b)) is amended by adding at the end the*
22 *following new paragraph:*

23 *“(4) REQUIREMENTS FOR AUDITS CONDUCTED*
24 *WITH REQUIREMENTS PAYMENTS.—*

1 “(A) *IN GENERAL.*—*An audit described in*
2 *paragraph (1) meets the requirements of this*
3 *paragraph if—*

4 “(i) *no individual who participates in*
5 *conducting the audit is an employee or con-*
6 *tractor of an office of the State or local gov-*
7 *ernment which is responsible for the admin-*
8 *istration of elections for Federal office or of*
9 *a subsidiary or affiliate of such an office;*
10 *and*

11 “(ii) *the audit includes an examina-*
12 *tion of compliance with established processes*
13 *for voter registration, voter check-in, voting,*
14 *tabulation, canvassing, post-election pro-*
15 *ceedings (such as recounts and recanvasses),*
16 *and reporting of results.*

17 “(B) *NONVOTING ELECTION TECHNOLOGY*
18 *DEFINED.*—*In paragraph (1), the term ‘non-*
19 *voting election technology’ means technology used*
20 *in the administration of elections for Federal of-*
21 *fice which is not used directly in the casting,*
22 *counting, tabulating, or collecting of ballots or*
23 *votes, including each of the following:*

1 “(i) *Electronic pollbooks or other sys-*
2 *tems used to check in voters at a polling*
3 *place or verify a voter’s identification.*

4 “(ii) *Election result reporting systems.*

5 “(iii) *Electronic ballot delivery sys-*
6 *tems.*

7 “(iv) *Online voter registration systems.*

8 “(v) *Polling place location search sys-*
9 *tems.*

10 “(vi) *Sample ballot portals.*

11 “(vii) *Signature systems.*

12 “(viii) *Such other technology as may*
13 *be recommended for treatment as nonvoting*
14 *election technology as the Standards Board*
15 *may recommend.”.*

16 (c) *SENSE OF CONGRESS REGARDING TIMING OF AU-*
17 *DITS.—It is the sense of Congress that post-election audits*
18 *of the effectiveness and accuracy of the voting systems, elec-*
19 *tion procedures, and outcomes used to carry out an election*
20 *for Federal office in a State and the performance of the*
21 *State and local election officials who carried out the election*
22 *are most effective when the audits are completed before the*
23 *expiration of the period during which persons are author-*
24 *ized under State law to challenge the results of the election.*
