REVENUE SHARING: (Constitutional Amendment) Phases out the state revenue sharing fund

A JOINT RESOLUTION

2	Proposing to amend Article VII, Section 26(B) of the Constitution of Louisiana, relative to
3	the revenue sharing fund; to phase out the annual allocation to the revenue sharing
4	fund; to provide for submission of the proposed amendment to the electors; and to
5	provide for related matters.
6	Section 1. Be it resolved by the Legislature of Louisiana, two-thirds of the members
7	elected to each house concurring, that there shall be submitted to the electors of the state of
8	Louisiana, for their approval or rejection in the manner provided by law, a proposal to
9	amend Article VII, Section 26(B) of the Constitution of Louisiana, to read as follows:
10	§26. Revenue Sharing Fund
11	Section 26.
12	* * *
13	(B) Annual Allocation. The sum of ninety million dollars is allocated
14	annually from the state general fund to the revenue sharing fund through Fiscal Year
15	2018-2019. For Fiscal Year 2019-2020 and each fiscal year thereafter, the annual
16	allocation from the state general fund to the revenue sharing fund shall be reduced
17	by twenty-two million five hundred thousand dollars from the prior fiscal year's
18	allocation, until there is no annual allocation from the state general fund to the
19	revenue sharing fund. The legislature may appropriate additional sums to the fund

1 Section 2. Be it further resolved that this proposed amendment shall be submitted 2 to the electors of the state of Louisiana at the statewide election to be held on October 14, 3 2017. However, if House Bill No. \_\_ of the 2017 Regular Session of the Legislature is not 4 enacted, the provisions of this Joint Resolution are hereby repealed in their entirety, the amendment proposed to the constitution proposed in this Act is hereby withdrawn, and the 5 6 secretary of state shall not print the proposition contained herein on the ballot of the 7 statewide election to be held on October 14, 2017. 8 Section 3. Be it further resolved that on the official ballot to be used at the election, 9 there shall be printed a proposition, upon which the electors of the state shall be permitted 10 to vote YES or NO, to amend the Constitution of Louisiana, which proposition shall read as 11 follows: 12 Do you support an amendment to implement a four-year phase out of the state's annual allocation to the revenue sharing fund established to offset 13 14 local revenue losses because of the homestead exemption? (Amends Article 15 VII, Section 26(B))

**Abstract:** Phases out the revenue sharing fund over four years beginning with FY 2019-2020.

<u>Present constitution</u> establishes the revenue sharing fund to be distributed annually to parishes for retirement systems and commissions, and for tax recipient bodies within each parish, to offset losses due to the homestead exemption.

<u>Present constitution</u> allocates \$90 million annually from the state general fund to the revenue sharing fund.

<u>Proposed constitutional amendment</u> reduces the allocation by \$22.5 million from the prior fiscal year's allocation each fiscal year beginning in FY 2019-2020 until the allocation is zero.

If HB No. \_\_\_\_ of the 2017 R.S. is enacted, provides for submission of the proposed amendment to the voters at the statewide election to be held October 14, 2017.
