## A BILL

To provide that the memorial to commemorate the sacrifice and service of the women who worked on the home front to support the efforts of the United States military during World War II may be located on the National Mall, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Women Who Worked  
5 on the Home Front Memorial Location Act”.

6 **SEC. 2. FINDINGS.**

7 Congress finds as follows:

1           (1) During World War II, more than 18 million  
2 women answered the call during a global crisis to  
3 hold down the home front by working as pilots, engi-  
4 neers, mechanics, code breakers, and more. These  
5 women built planes, tanks, munitions, and various  
6 other pieces of equipment needed to aid in the war  
7 effort.

8           (2) Section 702 of division DD of the Consoli-  
9 dated Appropriations Act, 2023 (40 U.S.C. 8903  
10 note; Public Law 117–328) authorized the Women  
11 Who Worked on the Home Front Foundation to es-  
12 tablish a memorial on Federal land in the District  
13 of Columbia and its environs to commemorate the  
14 service and sacrifice to the United States of the  
15 women who worked on the home front during World  
16 War II.

17           (3) Locating the commemorative work on the  
18 National Mall would be a respectful extension of the  
19 enduring legacy of the women who worked on the  
20 home front during World War II.

21 **SEC. 3. LOCATION OF MEMORIAL.**

22           Notwithstanding section 8908 of title 40, United  
23 States Code, the commemorative work to commemorate  
24 the commitment and service of the women who worked on  
25 the home front during World War II authorized by section

1 702 of division DD of the Consolidated Appropriations  
2 Act, 2023 (40 U.S.C. 8903 note; Public Law 117–328),  
3 may be located within—

4           (1) Area I, as depicted on the map entitled  
5           “Commemorative Areas Washington, DC and Envi-  
6           rons”, numbered 869/86501 B, and dated June 24,  
7           2003; or

8           (2) the Reserve (as defined in section 8902(a)  
9           of title 40, United States Code).
