1	An Act to update terminology related to ambulance operators.
2	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:
3	Section 1. That § 32-17-42 be AMENDED:
4	32-17-42. Any A motor vehicle authorized may be equipped with blue lights if it
5	<u>is:</u>
6	(1) Authorized by the Department of Transportation, a;
7	(2) A tow truck or wrecker as defined in § 32-17-107; or a vehicle operated
8	(3) Operated by a:
9	<u>(a) A</u> member of -an organized <u>a</u> fire department or organized search and rescue
10	unit or by a person who is an<u>; or</u>
11	(b) An ambulance driver, attendant, or emergency medical technician affiliated
12	with a licensed ambulance service may be equipped with blue lights
13	operator certified in accordance with chapter 36-4B.
14	This provision does not relieve the driver of the vehicle from the duty to drive with
15	due regard for the safety of all persons using the street, nor does it protect the driver
16	from the consequence of a reckless disregard-of for the safety of others.
17	No person may use a blue light unless the person is authorized by this chapter and
18	is operating a Department of Transportation vehicle or a county highway vehicle in
19	performance of winter highway maintenance duties, or the person is actually en route to
20	the scene of a fire or other emergency requiring the person's services and the person has
21	been authorized in writing to so use a blue light. Authorization for use of a blue light in
22	accordance with this chapter may be given by the Department of Transportation, the
23	highway patrol, <u>a</u> county highway superintendent, <u>the</u> chief of a fire department <u>, the</u>
24	coordinator of a search and rescue unit, or operator or ambulance service the director of
25	an ambulance service, and only to members of the department or service who are in good
26	standing.

The use of a blue light in violation of this section is a Class 2 misdemeanor.

2 Section 2. That § 32-31-4 be AMENDED:

3 32-31-4. The speed <u>limit limits</u> set <u>out forth</u> in §§ 32-25-1.1 to 32-25-17, 4 inclusive, <u>does do</u> not apply to any authorized emergency vehicle responding to an 5 emergency call if the driver sounds an audible siren or air horn, or both, or displays 6 flashing, oscillating, or rotating beams of red light, or combinations of red, blue, or white 7 light, visible one hundred eighty degrees to the front of the vehicle. The lights must be 8 capable of warning the public of the presence of an emergency vehicle under normal 9 atmospheric conditions.

The speed <u>limit limits</u> set<u>out forth</u> in §§ 32-25-1.1 to 32-25-17, inclusive, <u>does do</u>
 not apply to authorized emergency vehicles operated by law enforcement officers who are
 measuring the speed of other vehicles by use of the emergency vehicle speedometer.

13 An ambulance <u>driver who is operator</u> certified pursuant to chapter 36-4B may 14 operate an ambulance in excess of the speed limit without audible signals while operating 15 outside the city limits of a municipality.

16 Section 3. That § 34-11-12 be AMENDED:

- 17 **34-11-12.** Each ambulance run must include:
- 18 (1) One emergency medical technician or one advanced life support personnel,
 19 licensed pursuant to chapter 36-4B; and
- 20 (2) One driver ambulance operator certified in accordance with chapter 36-4B.

21 Section 4. That § 34-20A-100 be AMENDED:

- 34-20A-100. For the purposes of §§ 34-20A-98 to 34-20A-103, inclusive, the
 term, "first responder, includes" means:
- 24 (1) A law enforcement officer as defined by subdivision 22-1-2(22) § 22-1-2;
- 25 (2) <u>A driver and attendant An individual responding to an emergency call as part of an</u>
 26 ambulance service licensed pursuant to chapter 34-11; and or
- 27 (3) A firefighter.

28 Section 5. That § 36-4B-1 be AMENDED:

28	Section	6. That § 36-4B-35 be AMENDED:
29		36-4B-35. The board shall promulgate rules, pursuant to chapter 1-26, to:
30	(1)	Provide for an application form and process for the licensure of emergency medical
31	-	services personnel and the certification of ambulance drivers operators;
32	(2)	Set forth criteria for educational and training program approval, including
33		instructor qualifications, student acceptance, and clinical requirements;

1	(3)	Establish the educational and training requirements, and the National Registry of
2		Emergency Medical Technicians requirements, for applicants seeking licensure as
3		emergency medical services personnel;
4	(4)	Provide for the renewal of ambulance-driver operator certification and continuing
5		education requirements;
6	(5)	Establish procedures for the administration of the emergency medical services
7		personnel program;
8	(6)	Regulate the professional conduct of emergency medical services personnel and
9		ambulance-drivers_operators;
10	(7)	Establish the educational and training requirements, and conditions for issuance of
11		a critical care endorsement, as provided for in § 36-4B-18.1;
12	(8)	Establish the:
13		(a) Educational and training requirements and conditions for issuance of a
14		community paramedic endorsement; and
15		(b) Practice protocols and supervisory requirements for a person with a

19	Section	7. That § 36-4B-41 be AMENDED:
20		36-4B-41. The board may issue a certification as an ambulance driver operator to
21	a pers	son who:
22	(1)	Completes an emergency care course approved by the board; and

- 23 (2) Applies on a form prescribed by the board.
