A BILL

To increase the rates of pay under the statutory pay systems and for prevailing rate employees by 7.4 percent, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1 SECTION 1. SHORT TITLE.

- 2 This Act may be cited as the "Federal Adjustment
- 3 of Income Rates Act" or the "FAIR Act".

4 SEC. 2. ADJUSTMENT TO RATES OF PAY.

- 5 (a) Statutory Pay Systems.—For calendar year
- 6 2025, the percentage adjustment under section 5303 of
- 7 title 5, United States Code, in the rates of basic pay under
- 8 the statutory pay systems (as defined in section 5302 of
- 9 title 5, United States Code) shall be 4.0 percent.
- 10 (b) Prevailing Rate Employees.—Notwith-
- 11 standing the wage survey requirements under section
- 12 5343(b) of title 5, United States Code, for fiscal year
- 13 2025, the rates of basic pay (as in effect on the last day
- 14 of fiscal year 2024 under section 5343(a) of such title)
- 15 for prevailing rate employees in each wage area and the
- 16 rates of basic pay under sections 5348 and 5349 of such
- 17 title shall be increased by 4.0 percent.

18 SEC. 3. ADJUSTMENT TO LOCALITY PAY.

- 19 For calendar year 2025, the percentage adjustment
- 20 under section 5304 of title 5, United States Code, shall
- 21 be an increase of 3.4 percent.
