A BILL

To direct the Secretary of Veterans Affairs to carry out the Women's Health Transition Training pilot program through at least fiscal year 2020, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. ENCOURAGEMENT OF PARTICIPATION IN WOM-**
4 **EN'S HEALTH TRANSITION TRAINING PILOT**
5 **PROGRAM.**

6 (a) DURATION.—The Secretary of Veterans Affairs
7 shall carry out the Women's Health Transition Training

1 pilot program (in this section referred to as the “pilot pro-
2 gram”) until at least September 30, 2020.

3 (b) REPORT.—Not later than September 30, 2020,
4 the Secretary of Defense and the Secretary of Veterans
5 Affairs shall jointly submit to the appropriate congres-
6 sional committees a report on the pilot program that in-
7 cludes the following:

8 (1) For the period since the commencement of
9 the pilot program—

10 (A) the number of women members by
11 military department (with respect to Depart-
12 ment of the Navy, separately for the Navy and
13 Marine Corps) who participated in the pilot
14 program;

15 (B) the number of courses held under the
16 pilot program; and

17 (C) the locations at which such courses
18 were held, and the number of seats available
19 and the number of participants at each such lo-
20 cation.

21 (2) With respect to the number of members
22 who participated in the pilot program as specified
23 under paragraph (1)—

1 (A) the number who enrolled in the health
2 care system established under section 1705(a)
3 of title 38, United States Code; and

4 (B) the number who attended at least one
5 health care appointment at a medical facility of
6 the Department of Veterans Affairs.

7 (3) Data relating to—

8 (A) satisfaction with courses held under
9 the pilot program;

10 (B) improved awareness of health care
11 services administered by the Secretary of Vet-
12 erans Affairs; and

13 (C) any other available statistics regarding
14 the pilot program.

15 (4) A discussion of regulatory, legal, or resource
16 barriers to—

17 (A) making the pilot program permanent
18 to enable access by a greater number of women
19 members at locations throughout the United
20 States;

21 (B) offering the pilot program online for
22 women members who are unable to attend
23 courses held under the pilot program in person;
24 and

1 (C) the feasibility of automatically enroll-
2 ing pilot program participants in the health
3 care system established under section 1705(a)
4 of title 38, United States Code.

5 (c) APPROPRIATE CONGRESSIONAL COMMITTEES DE-
6 FINED.—In this section, the term “appropriate congres-
7 sional committees” means the Committees on Veterans’
8 Affairs and the Committees on Armed Services of the
9 House of Representatives and the Senate.
