To reauthorize the United States Anti-Doping Agency, and for other purposes.

1	Be it enacted by the Senate and House of Representa-
2	tives of the United States of America in Congress assembled,
3	SECTION 1. SHORT TITLE.
4	This Act may be cited as the "United States Anti-
5	Doping Agency Reauthorization Act of 2020".
6	SEC. 2. FINDINGS.
7	Congress makes the following findings:
8	(1) The United States Anti-Doping Agency—

 - (2) The United States Anti-Doping Agency contributes to the advancement of clean sport through scientific research, anti-doping education, and outreach programs, and the mission of the United States Anti-Doping Agency is to preserve the integrity of competition and protect the rights of athletes.
 - (3) Participation in youth sports has the potential to equip young athletes with important skills and values necessary for success in life, and it is essential that the culture of youth sports emphasizes such skills and values.
 - (4) The TrueSport program of the United States Anti-Doping Agency partners with youth sport organizations across the United States to promote sportsmanship, character building, and healthy performance through the use of targeted educational materials designed to promote a positive youth sport experience.

- 1 (5) In modifying the authority of the United 2 States Anti-Doping Agency to include the promotion 3 of the positive values of youth sport, Congress sends 4 a strong signal that the goals of youth sport should 5 include instilling in young athletes the values of in-6 tegrity, respect, teamwork, courage, and responsi-7 bility.
- Winted States in the global community, adequate funding of the anti-doping and clean sport programs of the United States Anti-Doping Agency is imperative to the preparation for the 2028 Summer Olympic Games, which will be held in Los Angeles, California.
 - (7) Increased appropriations for fiscal years 2021 through 2029 would enable the United States Anti-Doping Agency to directly affect the integrity and well-being of sport, both domestically and internationally.

(2) by adding at the end the following: 1 "(5) promote a positive youth sport experience 2 3 by using a portion of the funding of the United 4 States Anti-Doping Agency to provide educational 5 materials on sportsmanship, character building, and 6 healthy performance for the athletes, parents, and 7 coaches who participate in youth sports.". 8 SEC. 4. AUTHORIZATION OF APPROPRIATIONS. 9 Section 703 of the Office of National Drug Control Policy Reauthorization Act of 2006 (21 U.S.C. 2003) is 10 11 amended to read as follows: 12 "SEC. 703. AUTHORIZATION OF APPROPRIATIONS. 13 "There are authorized to be appropriated to the 14 United States Anti-Doping Agency— 15 "(1) for fiscal year 2021, \$15,500,000; "(2) for fiscal year 2022, \$16,200,000; 16 17 "(3) for fiscal year 2023, \$16,900,000; 18 "(4) for fiscal year 2024, \$17,700,000; 19 "(5) for fiscal year 2025, \$18,500,000; 20 "(6) for fiscal year 2026, \$19,800,000; "(7) for fiscal year 2027, \$22,100,000; 21 "(8) for fiscal year 2028, \$24,900,000; and 22 "(9) for fiscal year 2029, \$23,700,000.". 23

1 SEC. 5. INFORMATION SHARING.

- 2 Except as otherwise prohibited by law and except in
- 3 cases in which the integrity of a criminal investigation
- 4 would be affected, pursuant to the obligation of the United
- 5 States under Article 7 of the United Nations Educational,
- 6 Scientific, and Cultural Organization International Con-
- 7 vention Against Doping in Sport done at Paris October
- 8 19, 2005, and ratified by the United States in 2008, the
- 9 Attorney General, the Secretary of Homeland Security,
- 10 and the Commissioner of Food and Drugs shall provide
- 11 to the United States Anti-Doping Agency any relevant in-
- 12 formation relating to the prevention of the use of perform-
- 13 ance-enhancing drugs or the prohibition of performance-
- 14 enhancing methods.
