## A BILL

- 2 This Act may be cited as the "Selective Service Mod-
- 3 emization Act of 2020".
- 4 SEC. 2. MILITARY SELECTIVE SERVICE ACT MODERNIZA-
- 5 TION INITIATIVES.
- 6 (a) Maintenance of Registration Records.—
- 7 Section 10(b)(3) of the Military Selective Service Act (50
- 8 U.S.C. 3809(b)(3)) is amended by inserting after the first
- 9 sentence the following new sentence: "The President shall
- 10 ensure that the records of persons registered under this
- 11 title are periodically updated to exclude persons who are
- 12 no longer subject to induction into the Armed Forces of
- 13 the United States, such as deceased persons and persons
- 14 receiving supplemental security income benefits under title
- 15 XVI of the Social Security Act (42 U.S.C. 1381 et seq.)
- 16 due to a disability or Federally or State administered sup-
- 17 plemental benefits of the type described in section 212(a)
- 18 of Public Law 93-66 (42 U.S.C. 1382 note) due to a dis-
- 19 ability.".
- 20 (b) Expungement of Convictions and Sen-
- 21 Tences Commuted of Nonviolent Offenders.—Sec-
- 22 tion 6(m) of the Military Selective Service Act (50 U.S.C.
- 23 3806(m)) is amended by adding at the end the following
- 24 new sentence: "In the case of the induction of a person
- 25 convicted of other than a crime of violence (as defined in
- 26 section 16 of title 18, United States Code), upon the in-

- 1 duction of the person, the conviction shall be expunged
- 2 and the sentence commuted to time served.".
