RESOLUTION

Providing for consideration of the bill (H.R. 7608) making appropriations for the Department of State, foreign operations, and related programs for the fiscal year ending September 30, 2021, and for other purposes.

- 1 Resolved, That upon adoption of this resolution it
- 2 shall be in order to consider in the House the bill (H.R.
- 3 7608) making appropriations for the Department of State,
- 4 foreign operations, and related programs for the fiscal
- 5 year ending September 30, 2021, and for other purposes.
- 6 All points of order against consideration of the bill are
- 7 waived. An amendment in the nature of a substitute con-
- 8 sisting of the text of Rules Committee Print 116–59 shall
- 9 be considered as adopted. The bill, as amended, shall be
- 10 considered as read. All points of order against provisions
- 11 in the bill, as amended, are waived. Clause 2(e) of rule
- 12 XXI shall not apply during consideration of the bill. The
- 13 previous question shall be considered as ordered on the
- 14 bill, as amended, and on any further amendment thereto,
- 15 to final passage without intervening motion except: (1) one
- 16 hour of debate equally divided and controlled by the chair
- 17 and ranking minority member of the Committee on Appro-
- 18 priations; (2) the further amendments described in section
- 19 2 of this resolution; (3) the amendments en bloc described
- 20 in section 3 of this resolution; and (4) one motion to re-
- 21 commit with or without instructions.

- 1 Sec. 2. After debate pursuant to the first section of
- 2 this resolution, each further amendment printed in the re-
- 3 port of the Committee on Rules not earlier considered as
- 4 part of amendments en bloc pursuant to section 3 of this
- 5 resolution shall be considered only in the order printed in
- 6 the report, may be offered only by a Member designated
- 7 in the report, shall be considered as read, shall be debat-
- 8 able for the time specified in the report equally divided
- 9 and controlled by the proponent and an opponent, may
- 10 be withdrawn by the proponent at any time before the
- 11 question is put thereon, shall not be subject to amend-
- 12 ment, and shall not be subject to a demand for division
- 13 of the question.
- 14 Sec. 3. It shall be in order at any time after debate
- 15 pursuant to the first section of this resolution for the chair
- 16 of the Committee on Appropriations or her designee to
- 17 offer amendments en bloc consisting of further amend-
- 18 ments printed in the report of the Committee on Rules
- 19 accompanying this resolution not earlier disposed of.
- 20 Amendments en bloc offered pursuant to this section shall
- 21 be considered as read, shall be debatable for 30 minutes
- 22 equally divided and controlled by the chair and ranking
- 23 minority member of the Committee on Appropriations or
- 24 their respective designees, shall not be subject to amend-

- 1 ment, and shall not be subject to a demand for division
- 2 of the question.
- 3 Sec. 4. All points of order against the further amend-
- 4 ments printed in the report of the Committee on Rules
- 5 or amendments en bloc described in section 3 of this reso-
- 6 lution are waived.
- 7 Sec. 5. During consideration of the amendments de-
- 8 scribed in sections 2 and 3 of this resolution, it shall not
- 9 be in order to consider an amendment proposing both a
- 10 decrease in an appropriation designated pursuant to sec-
- 11 tion 251(b)(2)(A)(ii) of the Balanced Budget and Emer-
- 12 gency Deficit Control Act of 1985 and an increase in an
- 13 appropriation not so designated, or vice versa.
