### A BILL

- To amend the National Defense Authorization Act for Fiscal Year 2017 to address sexual harassment involving National Oceanic and Atmospheric Administration personnel, and for other purposes.
  - 1 Be it enacted by the Senate and House of Representa-
  - 2 tives of the United States of America in Congress assembled,

#### **3** SECTION 1. SHORT TITLE.

- 4 This Act may be cited as the "National Oceanic and
- 5 Atmospheric Administration Sexual Harassment and As-
- 6 sault Prevention Improvements Act of 2020".

#### 1 SEC. 2. REFERENCES.

2	Except as otherwise specifically provided, whenever in

8	SEC. 3. POLICY ON THE PREVENTION OF AND RESPONSE

#### 1 "SEC. 3546. INVESTIGATION REQUIREMENT.

2 "(a) Requirement To Investigate.—

"(1) IN GENERAL.—The Secretary of Commerce, acting through the Under Secretary for
Oceans and Atmosphere, shall ensure that each allegation of sexual harassment reported under section
3541 and each allegation of sexual assault reported
under section 3542 is investigated thoroughly and
promptly.

10 "(2) Sense of congress on commencement 11 OF INVESTIGATION.—It is the sense of Congress 12 that the Secretary should ensure that an investiga-13 tion of an alleged incident of sexual harassment re-14 ported under section 3541 or sexual assault reported 15 under section 3542 commences not later than 48 16 hours after the time at which the allegation was re-17 ported.

18 "(b) NOTIFICATION OF DELAY.-In any case in 19 which the time between the reporting of an alleged inci-20 dent of sexual harassment or sexual assault under section 21 3541 or 3542, respectively, and commencement of an in-22 vestigation of the allegation under this section exceeds 48 23 hours, the Secretary shall notify the Committee on Com-24 merce, Science, and Transportation of the Senate and the Committee on Natural Resources of the House of Rep-25 26 resentatives of the delay.

1 "SEC. 3547. CRIMINAL REFERRAL.

2 "If the Secretary of Commerce finds, pursuant to an
3 investigation under section 3546, evidence that a crime
4 may have been committed, the Secretary shall refer the
5 matter to the appropriate law enforcement authorities, in6 cluding the appropriate United States Attorney.

# 7 "SEC. 3548. EXCEPTIONS REGARDING ANONYMITY OF SUR8 VIVORS IN CERTAIN CASES.

9 "(a) IN GENERAL.—In any case in which an employee, member of the commissioned officer corps, or indi-10 vidual conducting business on behalf of the administration 11 elects anonymous reporting under section 3541(b)(3)(B)12 13 or 3542(b)(5)(B), disclosure of their personally identifying information is authorized to the following persons or orga-14 nizations when disclosure would be for the following rea-15 16 sons:

17 "(1) To National Oceanic and Atmospheric Ad18 ministration staff or law enforcement personnel,
19 when authorized by the survivor in writing.

20 "(2) To National Oceanic and Atmospheric Administration staff or law enforcement personnel to
22 prevent or lessen a serious or imminent threat to the
23 health or safety of the survivor or another person.
24 "(3) To a victim advocate or healthcare pro25 vider, when required for the provision of victim serv26 ices.

"(4) To a State or Federal court, when ordered
 by such court or if disclosure is required by Federal
 or State statute.

4 "(b) NOTICE OF DISCLOSURE AND PRIVACY PROTEC5 TION.—In any case in which information is disclosed
6 under subsection (a), the Secretary shall—

7 "(1) make reasonable attempts to provide no8 tice to the employee, member, or individual whose
9 personally identifying information is disclosed; and

10 "(2) take such action as is necessary to protect
11 the privacy and safety of the employee, member, or
12 individual.

#### 13 "SEC. 3549. RESTRICTED REPORTING.

14 "(a) IN GENERAL.—Not later than 3 years after the 15 date of enactment of the National Oceanic and Atmos-16 pheric Administration Sexual Harassment and Assault 17 Prevention Improvements Act of 2020, the Secretary of 18 Commerce, acting through the Under Secretary for 19 Oceans and Atmosphere, shall develop a mechanism to 20 provide a system of restricted reporting.

21 "(b) RESTRICTED REPORTING DEFINED.—In this
22 section the term 'restricted reporting' means a system of
23 reporting that allows employees of the National Oceanic
24 and Atmospheric Administration, members of the Com25 missioned Officer Corps of the Administration, and indi-

viduals who work with or conduct business on behalf of
 the Administration who are sexually assaulted to confiden tially disclose the details of their assault to specified indi viduals and receive the services outlined in this subtitle
 title—

6 "(1) without the dissemination of their person7 ally identifying information except as necessary for
8 the provision of such services; and

9 "(2) without automatically triggering an inves-10 tigative process.

#### 11 "SEC. 3550. MARINER REFERRAL.

12 "The Under Secretary of Commerce for Oceans and 13 Atmosphere, acting through the Director of the Office of Marine and Aviation Operations and in consultation with 14 15 the Commandant of the Coast Guard, shall, within 180 days after the date of the enactment of the National Oce-16 17 anic and Atmospheric Administration Sexual Harassment and Assault Prevention Improvements Act of 2020, de-18 19 velop and implement a policy to report to the Coast Guard Suspension and Revocation National Center of Expertise, 20 21 the names of personnel of the National Oceanic and At-22 mospheric Administration who-

23 "(1) are the subject of a claim of an act or of24 fense detrimental to good discipline and safety at
25 sea, such as sexual harassment or sexual assault

1	that is substantiated by an investigation under sec-
2	tion 3546, or any other substantiated claim of an
3	act or offense for which suspension or revocation of
4	a credential is either mandatory or sought pursuant
5	to part 5 of title 46 of the Code of Federal Regula-
6	tions; and
7	"(2) are—
8	"(A) employees or contractors of the Ad-
9	ministration required to hold a valid merchant
10	mariner credential as a condition of employ-
11	ment; or
12	"(B) crew of a vessel that, at the time of
13	such act or offence, was operating under a con-
14	tract with the Administration.".
15	SEC. 6. ANNUAL REPORT ON SEXUAL ASSAULTS, SEXUAL
16	HARASSMENT, AND EQUAL EMPLOYMENT.
