A BILL

To amend the public participation requirements of the Comprehensive Environmental Response, Compensation, and Liability Act of 1980, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Community Cleanup
- 5 Act".

1 SEC. 2. PUBLIC PARTICIPATION.

2	(a) Proposed Plan.—Section 117(a) of the Com-
3	prehensive Environmental Response, Compensation, and
4	Liability Act of 1980 (42 U.S.C. 9617(a)) is amended—
5	(1) in the matter preceding paragraph (1), by
6	striking "both of";
7	(2) by redesignating paragraph (2) as para-
8	graph (3);
9	(3) by inserting after paragraph (1) the fol-
10	lowing:
11	"(2) Transmit the notice and analysis published
12	under paragraph (1) to officials for the local govern-
13	ment with jurisdiction over the facility at issue, in-
14	cluding—
15	"(A) any applicable mayor or city council;
16	and
17	"(B) if no mayor or city council is avail-
18	able, the highest ranking official of such local
19	government, as applicable."; and
20	(4) in paragraph (3) (as redesignated by para-
21	graph (2) of this subsection) by inserting "(includ-
22	ing comments regarding use of the facility at issue
23	after remedial action is taken)" after "written and
24	oral comments".
25	(b) Final Plan.—Section 117(b) of the Comprehen-
26	sive Environmental Response, Compensation, and Liabil-

- 4 (c) Publication.—Section 117(d) of the Com-

- 6 Liability Act of 1980 (42 U.S.C. 9617(d)) is amended—
- 7 (1) by inserting "and require" after "publica-8 tion shall include"; and
- 9 (2) by striking "general circulation." and in-10 serting "general circulation (if available), announce-11 ment sent to a radio station, or television station, 12 the broadcast area of which includes the community 13 surrounding the facility at issue, and posting to the 14 website of the Environmental Protection Agency.".
