

7	The General Ass	embly of North Carolina enacts:
8	SECT	TION 1. This act shall be known and may be cited as the "Save Spring Break
9	Act."	
10	SECT	FION 2. G.S. 115C-84.2 reads as rewritten:

12	(a) Schoo	ol Calendar Each local board of education shall adopt a school calendar
13	consisting of 215	days all of which shall fall within the fiscal year. A school calendar shall include
14	the following:	
15	(1)	A minimum of 185 days or 1,025 hours of instruction covering at least nine
16		calendar months. The local board shall designate when the instructional days
17		shall occur. The number of instructional hours in an instructional day may
18		vary according to local board policy and does not have to be uniform among
19		the schools in the administrative unit. Local boards may approve school
20		improvement plans that include days with varying amounts of instructional
21		time. If school is closed early due to inclement weather, weather or another
22		emergency scenario, the day and the scheduled amount of instructional hours
23		may count towards the required minimum to the extent allowed by State Board
24		policy. The school calendar shall include a plan for making up days and
25		instructional hours missed when schools are not opened due to inclement
26		weather.weather or another emergency scenario. This plan may include the
27		use of remote instruction for one or more schools in accordance with this
28		subsection to meet the required number of instructional days and hours.

30	(2)	A minimum of 10 annual vacation leave days.
31	(3)	The same or an equivalent number of legal holidays occurring within the
32		school calendar as those designated by the State Human Resources

35	(5)	The remaining days scheduled by the local board in consultation with each
36		school's principal for use as teacher workdays, additional instructional days,

	application components to demonstrate learning. The plan shall include
	process for monitoring the quality of remote instruction materials.
