# **A BILL**

To prohibit individuals who are not citizens of the United States from voting in elections in the District of Columbia.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. PROHIBITING VOTING BY NONCITIZENS IN DIS-**  
4 **TRICT OF COLUMBIA ELECTIONS.**

5        *An individual who is not a citizen of the United States*  
6 *may not vote in an election for public office in the District*  
7 *of Columbia or in any ballot initiative or referendum in*  
8 *the District of Columbia.*

9 **SEC. 2. REPEAL OF LOCAL RESIDENT VOTING RIGHTS**  
10 **AMENDMENT ACT OF 2022.**

11        *The Local Resident Voting Rights Amendment Act of*  
12 *2022 (D.C. Law 24–242) is repealed, and any provision*  
13 *of law amended or repealed by such Act shall be restored*  
14 *or revived as if such Act had not been enacted into law.*

Amend the title so as to read: “A bill to prohibit in-  
dividuals who are not citizens of the United States from  
voting in elections in the District of Columbia and to re-  
peal the Local Resident Voting Rights Amendment Act of  
2022.”.
