Natural Resources - Hunting - Deer Management Permits

- FOR the purpose of authorizing a person to hunt deer under a Deer Management Permit on any Sunday throughout the year, including all deer hunting seasons; altering the application of certain provisions of law governing Deer Management Permits in Charles County and St. Mary's County; making certain conforming changes; altering a certain definition; making a certain stylistic change; making this Act an emergency measure; and generally relating to hunting deer under a Deer Management Permit.

- 19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 20 That the Laws of Maryland read as follows:

Turkey on a regulated shooting ground that was permitted 20 to release turkey before September 1, 1992; and 21Having the written permission of the owner of the land or 22 other person designated by the owner of the land, if the land is owned or leased by a person 23other than the person hunting on Sundays; 24Subject to the provisions of § 10–411 of this subtitle, in Calvert, Caroline, Carroll, Charles, Dorchester, Harford, Queen Anne's, St. Mary's, Somerset, 2526 Talbot, Wicomico, and Worcester counties, a person hunting deer on private property with 27 a bow and arrow or crossbow during open season on the last three Sundays in October and 28 the second Sunday in November;
- (v) In Calvert County, Caroline County, Carroll County, Charles County, Dorchester County, and St. Mary's County, a person hunting turkey on private property on any Sunday during the spring turkey hunting season; [and]

1 2 3	(vi) In Dorchester County, a person hunting turkey on public land that is designated for hunting by the Department on any Sunday during the spring turkey hunting season; AND
4 5 6	(VII) A PERSON HUNTING DEER UNDER A DEER MANAGEMENT PERMIT ON ANY SUNDAY THROUGHOUT THE YEAR, INCLUDING ALL DEER HUNTING SEASONS.

8 9 10	(d) (1) In this subsection, "Deer Management Permit" means a permit issued by the Department authorizing the holder OR AN AGENT OF THE HOLDER to hunt deer outside of deer hunting season for the purpose of preventing damage to crops.
11 12	(2) [(i)] In Charles County and St. Mary's County, an individual who [holds] HUNTS DEER UNDER a Deer Management Permit may:
13 14 15	[1.] (I) Use a shotgun or breech loading center fired rifle approved by the Department to hunt deer throughout the year, including all deer hunting seasons, in the locations and under the conditions set forth in the permit; and
16 17 18 19	[2.] (II) [If the individual leases] ON State land in Charles County or St. Mary's County LEASED BY THE PERMIT HOLDER for the purpose of cultivating crops, hunt deer on the LEASED land [leased by the individual] in the locations and under the conditions set forth in the permit.
20 21	[(ii) The Department may authorize an individual in Charles County or St. Mary's County to hunt deer on Sundays under a Deer Management Permit.]
22 23	(3) To protect public safety and welfare, the Department may restrict the lands on which an individual may hunt deer under a Deer Management Permit.
24 25 26	SECTION 2. AND BE IT FURTHER ENACTED, That this Act is an emergency measure, is necessary for the immediate preservation of the public health or safety, has been passed by a yea and nay vote supported by three–fifths of all the members elected to

each of the two Houses of the General Assembly, and shall take effect from the date it is
