## A BILL

To facilitate construction of a bridge on certain property  
in Christian County, Missouri, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. RIVERSIDE BRIDGE PROJECT.**

4       ~~(a) IN GENERAL.—The Riverside Bridge Project is~~  
5       ~~authorized to be carried out notwithstanding—~~

1           ~~(1) any agreement entered into under, or re-~~  
 2           ~~striction pursuant to, section 404(b)(2) of the Rob-~~  
 3           ~~ert T. Stafford Disaster Relief and Emergency As-~~  
 4           ~~sistance Act (42 U.S.C. 5170c(b)(2)); or~~

5           (2) any other Federal restriction that requires  
 6           the covered property to be maintained for open  
 7           space, recreation, or wetland management.

8           (b) CONDITIONS.—As a condition of the authoriza-  
 9           tion under subsection (a), Christian County, Missouri—

10           (1) shall carry out the Riverside Bridge Project  
 11           in a manner that ensures that no flood damage at-  
 12           tributable to the Project occurs; and

13           (2) shall be liable for any such flood damage  
 14           that does occur.

15           (c) DISASTER ASSISTANCE PROHIBITED.—No Fed-  
 16           eral financial assistance pursuant to the Robert T. Staf-  
 17           ford Disaster Relief and Emergency Assistance Act (42  
 18           U.S.C. 5121 et seq.) may be provided with respect to the  
 19           covered property or any improvements thereon.

20           (d) DEFINITIONS.—In this Act, the following defini-  
 21           tions apply:

22           (1) COVERED PROPERTY.—The term “covered  
 23           property” means the property—

24           (A) in Christian County, Missouri;

1           ~~(B)~~ conveyed to such County by the River-  
 2           side Inn, Inc.; and

3           ~~(C)~~ that is approximately 1.5 acres and  
 4           482 lineal feet adjacent to the westerly line of  
 5           Riverside Road to the center of Finley Creek.

11           ~~(a) IN GENERAL.—~~*The Riverside Bridge Project is au-*  
 12 *thorized to be carried out notwithstanding—*

 14 *tion pursuant to, section 404(b)(2) of the Robert T.*  
 15 *Stafford Disaster Relief and Emergency Assistance*

17           ~~(2) any easement or other Federal restriction~~  
 18 *pursuant to that Act (42 U.S.C. 5121 et seq.) that re-*  
 19 *quires the covered property to be maintained for open*  
 20 *space, recreation, or wetland management.*

21           ~~(b) CONDITIONS.—~~*As a condition of the authorization*  
 22 *under subsection (a)—*

23           ~~(1) Christian County, Missouri, or an assignee~~  
 24 *shall—*

1           (A) carry out the Riverside Bridge Project  
 2           in a manner that ensures that no flood damage  
 3           attributable to the Project occurs; and

4           (B) be liable for any such flood damage that  
 5           does occur; and

6           (2) the Federal Government shall not be liable  
 7           for future flood damage that is caused by the Project.

8           (c) *DISASTER ASSISTANCE PROHIBITED.*—No future  
 9           disaster assistance from any Federal source may be pro-  
 10          vided with respect to the covered property or any improve-  
 11          ments thereon.

12          (d) *DEFINITIONS.*—In this Act, the following defini-  
 13          tions apply:

14           (1) *COVERED PROPERTY.*—The term “covered  
 15           property” means the property—

16           (A) in Christian County, Missouri;

17           (B) conveyed to such County by the River-  
 18           side Inn, Inc.; and

19           (C) that is approximately 1.5 acres and 482  
 20           lineal feet adjacent to the westerly line of River-  
 21           side Road to the center of Finley Creek.

22           (2) *RIVERSIDE BRIDGE PROJECT.*—The term  
 23           “Riverside Bridge Project” means the project to con-  
 24           struct, maintain, and operate a bridge on and over  
 25           the covered property.
