AMENDATORY Section 1, Chapter 123, O.S.L. 2016 (62 O.S. Supp. 2019, Section 35.6.2), is amended to read as 13 follows: 14 15 Section 35.6.2. A. In order to comply with Executive Orders and federal and state statutory and regulatory requirements related 16 to interoperable public safety communications and to support the 17 critical mission and purposes of the agencies within the Oklahoma 18 Safety and Security Cabinet, the Transportation Cabinet and the 19 Finance, Administration and Information Technology Cabinet, there is 20 hereby established the Land Mobile Radio Public Safety 21 Interoperability Cooperative. The Land Mobile Radio Public Safety 22 Interoperability Cooperative shall be governed by a committee 23 initially consisting of the Secretary of Finance, Administration and 24

1 Information Technology or designee, the Secretary of Transportation 2 or designee and the Secretary of Safety and Security or designee. The Cooperative is established to focus on unifying, stabilizing and 3 enhancing the infrastructure and capabilities for land mobile radio 4 5 public safety system communications for the State of Oklahoma this state and shall include representatives of other public radio system 6 boards or committees along with future voting or non-voting public 7 entity members as deemed appropriate, nominated and agreed to by 8 9 vote of the committee members defined in this paragraph.

B. 1. In establishing and operating the Land Mobile Radio
Public Safety Interoperability Cooperative, the committee shall
collaborate with other public agencies, public entities and other
interested parties having public safety radio communications
requirements and resources.

15 2. The Cooperative shall establish an appropriate governance 16 model for determining priorities, leveraging state-owned or other 17 shared services and infrastructure, identifying existing and new 18 resources and directing new investments to facilitate reliable, 19 statewide and fully operational public safety radio communications 20 to serve the purposes described.

3. In support of the requirements of the Oklahoma Homeland
Security Act, the Oklahoma Information Services Act and the
Information Technology Consolidation and Coordination Act, the
Cooperative shall have the following duties:

- 1a.enable cost savings to the State of Oklahoma state2through unification and enhancement of current land3mobile radio public safety systems,
- 4 b. sustain existing interoperability of land mobile
 5 public safety radio systems,
- c. recommend standards and protocols for land mobile
 radio public safety systems,
- 8 d. recommend standards to become P25 compliant and other
 9 common radio interoperability standards, and
- e. establish service metrics to ensure reliable land
 mobile public safety services statewide in support of
 state, local and first responders.

C. Actions, decisions and operation of the Land Mobile Radio 13 Public Safety Interoperability Cooperative shall be performed in 14 compliance with, in support of and secondary to all statutory 15 duties, requirements, responsibilities and authority provided to the 16 17 Office of Management and Enterprise Services and the Oklahoma Office of Homeland Security; however, the resources and mechanisms 18 available to Cooperative members by ownership or through agreement 19 may be collectively utilized to carry out the provisions of this 20 statute. 21

D. Effective January 1, 2021, any new public safety radio
 network purchased by any law enforcement agency in this state
 including, but not limited to, municipalities and sheriff offices,
