A BILL

To authorize the National Medal of Honor Museum Foundation to establish a commemorative work on the National Mall to honor the extraordinary acts of valor, selfless service, and sacrifice displayed by Medal of Honor recipients.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Hershel ‘Woody’ Wil-*
5 *liams National Medal of Honor Monument Location Act”.*

6 **SEC. 2. FINDINGS.**

7 *Congress finds the following:*

8 *(1) Congress in 2021 unanimously passed, and*
9 *the President signed, Public Law 117–80 (40 U.S.C.*
10 *8903 note), which authorized the National Medal of*
11 *Honor Museum Foundation to establish on Federal*
12 *land in the District of Columbia a commemorative*
13 *work to honor the acts of valor, selfless service, and*
14 *sacrifice displayed by Medal of Honor recipients.*

15 *(2) The Medal of Honor was established by*
16 *President Abraham Lincoln and first awarded 160*
17 *years ago on March 25, 1863, and is part of Lincoln’s*
18 *lasting and living legacy.*

19 *(3) In 1991, during the administration of Presi-*
20 *dent George H.W. Bush, this legacy was extended fur-*
21 *ther when National Medal of Honor Day was estab-*
22 *lished as March 25th of each year.*

23 *(4) The Medal of Honor is awarded to all*
24 *branches of the United States Armed Forces as our*
25 *nation’s highest recognition for valor in combat.*

1 (5) *The number of living Medal of Honor recipi-*
2 *ents has been steadily declining, making it even more*
3 *crucial to honor and recognize their heroic sacrifices*
4 *and inspire future generations.*

5 (6) *Hershel “Woody” Williams, the last World*
6 *War II Medal of Honor recipient, passed away in*
7 *2022 and laid in honor at the United States Capitol.*

8 (7) *The Medal of Honor represents the very best*
9 *of our Nation—ordinary citizens, who took extraor-*
10 *inary action above and beyond the call of duty and*
11 *became heroes of our Republic.*

12 (8) *These examples inspire all citizens and ignite*
13 *within us the very spirit of America.*

14 (9) *The Medal of Honor rises to the level of su-*
15 *preme national and historical importance necessary*
16 *to warrant representation on the National Mall.*

17 (10) *Locating the National Medal of Honor*
18 *Monument in close proximity to the Lincoln Memo-*
19 *rial within the Reserve would be a respectful exten-*
20 *sion of his enduring legacy and recognition of what*
21 *ordinary people can accomplish when working for the*
22 *greater good.*

1 **SEC. 3. NATIONAL MEDAL OF HONOR MONUMENT LOCA-**
2 **TION.**

3 (a) *SITE.*—*Notwithstanding section 8908(c) of title 40,*
4 *United States Code, the commemorative work authorized by*
5 *section 1(a) of Public Law 117–80 (40 U.S.C. 8903 note)*
6 *shall be located within the Reserve (as defined in section*
7 *8902(a) of title 40, United States Code).*

8 (b) *APPLICABILITY OF COMMEMORATIVE WORKS*
9 *ACT.*—*Except as provided in subsection (a), chapter 89 of*
10 *title 40, United States Code (commonly known as the*
11 *“Commemorative Works Act”), shall apply to the com-*
12 *memorative work.*
