A BILL

To amend title 38, United States Code, to clarify presump-

tions relating to the exposure of certain veterans who served in the vicinity of the Republic of Vietnam, and for other purposes.

Be it enacted by the Senate and House of Representa tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Blue Water Navy Viet-5 nam Veterans Act of 2019".

6 SEC. 2. CLARIFICATION OF PRESUMPTIONS OF EXPOSURE
7 FOR VETERANS WHO SERVED IN VICINITY OF
8 REPUBLIC OF VIETNAM.

9 (a) IN GENERAL.—Chapter 11 of title 38, United
10 States Code, is amended by inserting after section 1116
11 the following new section:

12 "§ 1116A. Presumptions of service connection for vet-

13 erans who served offshore of the Repub-14 lic of Vietnam

15 "(a) SERVICE CONNECTION.—For the purposes of section 1110 of this title, and subject to section 1113 of 16 this title, a disease covered by section 1116 of this title 17 18 becoming manifest as specified in that section in a veteran 19 who, during active military, naval, or air service, served 20 offshore of the Republic of Vietnam during the period beginning on January 9, 1962, and ending on May 7, 1975, 21 22 shall be considered to have been incurred in or aggravated 23 by such service, notwithstanding that there is no record of evidence of such disease during the period of such serv ice.

3 "(b) EXPOSURE.—A veteran who, during active mili-4 tary, naval, or air service, served offshore of the Republic 5 of Vietnam during the period beginning on January 9, 1962, and ending on May 7, 1975, shall be presumed to 6 7 have been exposed during such service to an herbicide 8 agent unless there is affirmative evidence to establish that 9 the veteran was not exposed to any such agent during that 10 service.

"(c) EFFECTIVE DATE OF AWARD.—(1) Except as
provided by paragraph (2), the effective date of an award
under this section shall be determined in accordance with
section 5110 of this title.

((2)(A) Notwithstanding subsection (g) of section 15 5110 of this title, the Secretary shall determine the effec-16 tive date of an award based on a claim under this section 17 for an individual described in subparagraph (B) by treat-18 ing the date on which the individual filed the prior claim 19 specified in clause (i) of such subparagraph as the date 20 21 on which the individual filed the claim so awarded under 22 this section.

23 "(B) An individual described in this subparagraph is
24 a veteran, or a survivor of a veteran, who meets the fol25 lowing criteria:

"(i) The veteran or survivor submitted a claim for disability compensation on or after September 25, 1985, and before January 1, 2020, for a disease covered by this section, and the claim was denied by reason of the claim not establishing that the disease

6 was incurred or aggravated by the service of the vet-7 eran.

8 "(ii) The veteran or survivor submits a claim 9 for disability compensation on or after January 1, 10 2020, for the same condition covered by the prior 11 claim under clause (i), and the claim is approved 12 pursuant to this section.

13 "(d) DETERMINATION OF OFFSHORE.—Notwith-14 standing any other provision of law, for purposes of this 15 section, the Secretary shall treat a location as being off-16 shore of Vietnam if the location is not more than 12 nau-17 tical miles seaward of a line commencing on the south-18 western demarcation line of the waters of Vietnam and 19 Cambodia and intersecting the following points:

 claim for disability compensation under section
 1116A of title 38, United States Code, as added by
 subsection (a).

5 (2) VETERAN DESCRIBED.—A veteran described
6 in this paragraph is a veteran who, during active
7 military, naval, or air service, served offshore of the
8 Republic of Vietnam during the period beginning on
9 January 9, 1962, and ending on May 7, 1975.

10 (e) REPORTS.—Not later than January 1, 2020, and not later than January 1, 2022, the Secretary of Veterans 11 Affairs shall submit to the Committees on Veterans' Af-12 13 fairs of the House of Representatives and the Senate a report on claims for disability compensation under section 14 15 1116A of title 38, United States Code, as added by subsection (a). Each report shall include the following with 16 17 respect to the period covered by the report, disaggregated by the regional offices of the Department of Veterans Af-18 19 fairs:

20 (1) The number of claims filed under such sec-21 tion.

22 (2) The number of such claims granted.

23 (3) The number of such claims denied.

6 SEC. 3. PRESUMPTION OF HERBICIDE EXPOSURE FOR CER7 TAIN VETERANS WHO SERVED IN KOREA.

8 (a) IN GENERAL.—Chapter 11 of title 38, United
9 States Code, is amended by inserting after section 1116A,
10 as added by section 2, the following new section:

11 "§ 1116B. Presumption of herbicide exposure for cer12 tain veterans who served in Korea

13 "(a) PRESUMPTION OF SERVICE-CONNECTION.—(1) For the purposes of section 1110 of this title, and subject 14 15 to section 1113 of this title, a disease specified in subsection (b) that becomes manifest as specified in that sub-16 section in a veteran described in paragraph (2) shall be 17 18 considered to have been incurred or aggravated in the line of duty in the active military, naval, or air service, not-19 withstanding that there is no record of evidence of such 20 21 disease during the period of such service.

"(2) A veteran described in this paragraph is a veteran who, during active military, naval, or air service,
served in or near the Korean Demilitarized Zone (DMZ),

1	during the period beginning on September 1, 1967, and
2	ending on August 31, 1971.
3	"(b) DISEASES.—A disease specified in this sub-
4	section is—
5	((1) a disease specified in paragraph (2) of
6	subsection (a) of section 1116 of this title that be-
7	comes manifest as specified in that paragraph; or
8	"(2) any additional disease that—
9	"(A) the Secretary determines in regula-
10	tions warrants a presumption of service-connec-
11	tion by reason of having positive association
12	with exposure to an herbicide agent; and
13	"(B) becomes manifest within any period
14	prescribed in such regulations.
15	"(c) Herbicide Agent.—For purposes of this sec-
16	tion, the term 'herbicide agent' has the meaning given
17	such term in section 1821(d) of this title.".

20	(a) IN GENERAL.—Subchapter III of chapter 18 of
21	title 38, United States Code, is amended by adding at the
22	end the following new section:

1 "§ 1822. Benefits for children of certain Thailand 2 service veterans born with spina bifida

"(a) BENEFITS AUTHORIZED.—The Secretary may 3 provide to any child of a veteran of covered service in 4 5 Thailand who is suffering from spina bifida the health care, vocational training and rehabilitation, and monetary 6 7 allowance required to be paid to a child of a Vietnam veteran who is suffering from spina bifida under subchapter 8 I of this chapter as if such child of a veteran of covered 9 10 service in Thailand were a child of a Vietnam veteran who 11 is suffering from spina bifida under such subchapter.

12 "(b) SPINA BIFIDA CONDITIONS COVERED.—This
13 section applies with respect to all forms and manifesta14 tions of spina bifida, except spina bifida occulta.

15 "(c) VETERAN OF COVERED SERVICE IN THAI16 LAND.—For purposes of this section, a veteran of covered
17 service in Thailand is any individual, without regard to
18 the characterization of that individual's service, who—

"(1) served in the active military, naval, or air
service in Thailand, as determined by the Secretary
in consultation with the Secretary of Defense, during the period beginning on January 9, 1962, and
ending on May 7, 1975; and

24 "(2) is determined by the Secretary, in con-25 sultation with the Secretary of Defense, to have been

exposed to a herbicide agent during such service in
 Thailand.

3 "(d) HERBICIDE AGENT.—For purposes of this sec-4 tion, the term 'herbicide agent' means a chemical in a her-5 bicide used in support of United States and allied military operations in Thailand, as determined by the Secretary in 6 7 consultation with the Secretary of Defense, during the pe-8 riod beginning on January 9, 1962, and ending on May 7, 1975.". 9 10 (b) Conforming Amendment to Definition of "CHILD".—Section 1831(1) of such title is amended— 11 12 (1) in subparagraph (B)— 13 (A) by striking "subchapter III of this 14 chapter" and inserting "section 1821 of this 15 title"; and 16 (B) in clause (i), by striking "section 1821 17 of this title" and inserting "that section"; and 18 (2) by adding at the end the following new sub-19 paragraph: "(C) For purposes of section 1822 of this 20 21 title, an individual, regardless of age or marital 22 status, who— "(i) is the natural child of a veteran 23 24 of covered service in Thailand (as deter-25 mined for purposes of that section); and

13 Affairs, in consultation with the Secretary of Defense,
14 shall submit to the Committees on Veterans' Affairs of
15 the House of Representatives and the Senate a report
16 identifying—

(1) the military installations of the United
States located in Thailand during the period beginning on January 9, 1962, and ending on May 7,
1975, at which an herbicide agent (as defined in section 1822 of title 38, United States Code, as added
by subsection (a)) was actively used; and
(2) the period of such use.

19 "(3) The Secretary shall permit an appraiser on a 20 list developed and maintained under subsection (a)(3) to 21 make an appraisal for the purposes of this chapter based 22 solely on information gathered by a person with whom the 23 appraiser has entered into an agreement for such serv-24 ices.".

(b) EFFECTIVE DATE.—The amendments made by 1 this section shall apply with respect to an appraisal under 2 3 section 3731 of such title, on or after January 1, 2020. 4 (c) GUIDANCE.—Notwithstanding section 501 of such 5 title, the Secretary of Veterans Affairs may issue guidance to implement this section before prescribing new regula-6 tions under sections 3731 of such title, as amended by 7 subsection (a). 8
