- 17 Ministry of Foreign Affairs in Athens, Greece; and
- 18 WHEREAS, his hard work and dedication were recognized by his employers and peers,
- 19 allowing him the opportunity to serve in several leadership capacities, such as Consul at the
- 20 Consulate General of Greece in Sydney, the First Secretary with the Embassy of Greece in
- 21 Ankara, Counselor for Political and Economic Affairs, the Deputy Head of the Diplomatic
