1 AN ACT concerning

2 **Tri-County Council for Southern Maryland – Funding**

3 FOR the purpose of increasing the amount of money that the county commissioners of
4 Calvert County, Charles County, and St. Mary's County are required to appropriate
5 each year for the Tri-County Council for Southern Maryland to foster cooperative
6 planning and development in the region; and generally relating to funding for the
7 Tri-County Council for Southern Maryland.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
19 That the Laws of Maryland read as follows:

20 **Article – Economic Development**

2 (a) In this subtitle the following words have the meanings indicated.

3 (c) "Council" means the Tri-County Council for Southern Maryland.

4 13-611.

5 (a) The State and Calvert, Charles, and St. Mary's counties may jointly finance
6 the Council and its activities.

7 (b) (1) The State may provide financial support to the Council to assist in
8 carrying out the activities of the Council.

9 (2) (i) On or before August 1 of each year, the Council shall submit its
10 proposed work programs and operating budget for the following fiscal year to the
11 Department.

12 (ii) The submission shall include supporting schedules to show how
13 the budget is financed, and to provide for review and recommendations.

14 (iii) After review, the Department shall forward the submission and
15 any recommendations to the Department of Budget and Management for consideration.

16 (3) The Governor shall include in the State budget for the following fiscal
17 year an appropriation to partially support the Council.

18 (c) (1) The county commissioners of Calvert, Charles, and St. Mary's counties
19 shall appropriate money each year for the Council to foster cooperative planning and
20 development in the region as follows:

21 (i) Calvert County – ~~[\$7,000]~~ **\$125,000**;

22 (ii) Charles County – ~~[\$9,000]~~ **\$125,000**; and

23 (iii) St. Mary's County – ~~[\$9,000]~~ **\$125,000**.

24 (2) Calvert, Charles, and St. Mary's counties may appropriate any other
25 money for the Council as they consider necessary and appropriate.

26 (d) The Council may accept additional money from any other public or private
27 source.

28 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
29 1, 2020.
