15 16	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

19	(a) This section does not apply to:
20	(1) a law enforcement officer in the regular course of the officer's duty;
21	(2) an off–duty law enforcement officer or a person who has retired as a law



- enforcement officer in good standing from a law enforcement agency of the United States, 1 2the State, or a local unit in the State who is a parent, guardian, or visitor of a student 3 attending a school located on the public **OR NONPUBLIC** school property, provided that: 4 the officer or retired officer is displaying the officer's or retired (i) 5 officer's badge or credential; 6 the weapon carried or possessed by the officer or retired officer is (ii) 7 concealed; and 8 the officer or retired officer is authorized to carry a concealed (iii) 9 handgun in the State; 10 a person hired by: (3) 11 a county board of education specifically for the purpose of **(I)** 12 guarding public school property; OR 13 (II)A NONPUBLIC SCHOOL SPECIFICALLY FOR THE PURPOSE OF **GUARDING NONPUBLIC SCHOOL PROPERTY;** 14 15 **(4)** a person engaged in organized shooting activity for educational 16 purposes; or 17 a person who, with a written invitation from the school principal, (5)displays or engages in a historical demonstration using a weapon or a replica of a weapon 18 19 for educational purposes. 20 A person may not carry or possess a firearm, knife, or deadly weapon of any 21kind on public OR NONPUBLIC school property. 22 Except as provided in paragraph (2) of this subsection, a person who (c) 23violates this section is guilty of a misdemeanor and on conviction is subject to imprisonment 24not exceeding 3 years or a fine not exceeding \$1,000 or both.
- 25(2) A person who is convicted of carrying or possessing a handgun in violation of this section shall be sentenced under Subtitle 2 of this title. 26
