Peace Orders - Workplace Violence

- 3 FOR the purpose of making certain provisions of law relating to the filing, issuance, and 4 modification of certain peace orders and to the shielding of certain court records of 5 certain peace order proceedings apply to certain peace orders filed by certain 6 employers on the basis of certain acts committed against certain employees under 7 certain circumstances; requiring an employer to notify an employee before an 8 employee files a certain petition; providing certain immunity from certain liability 9 to a certain employer under certain circumstances; prohibiting an employer from retaliating against an employee under certain circumstances; making certain 10 11 conforming changes; defining certain terms; providing for the application of a certain 12 provision of this Act; and generally relating to peace orders.

- 18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 19 That the Laws of Maryland read as follows:

- 22 (a) In this subtitle the following words have the meanings indicated.
- 23 (b) "Commissioner" means a District Court commissioner appointed in accordance with Article IV, § 41G of the Maryland Constitution.

- 1 (c) "Court" means the District Court of Maryland.
- 2 (D) "EMPLOYEE" MEANS:
- 3 (1) AN INDIVIDUAL WHO IS EMPLOYED BY AN EMPLOYER; OR
- 4 (2) A VOLUNTEER OR AN INDEPENDENT CONTRACTOR WHO 5 PERFORMS SERVICES FOR AN EMPLOYER AT THE EMPLOYER'S WORKPLACE.
- 6 (E) (1) "EMPLOYER" MEANS A PERSON ENGAGED IN A BUSINESS, AN 7 INDUSTRY, A PROFESSION, A TRADE, OR ANY OTHER ENTERPRISE IN THE STATE.
- 8 (2) "EMPLOYER" INCLUDES A PERSON THAT ACTS DIRECTLY OR 9 INDIRECTLY IN THE INTEREST OF ANOTHER EMPLOYER WITH AN EMPLOYEE.
- 10 **[**(d)**] (F)** "Final peace order" means a peace order issued by a judge under § 11 3–1505 of this subtitle.
- [(e)] (G) "Interim peace order" means an order that a commissioner issues under this subtitle pending a hearing by a judge on a petition.
- 14 **[**(f)**] (H)** "Petitioner" means an individual who files a petition under § 3–1503 of 15 this subtitle.
- 16 **[(g)] (I)** "Residence" includes the yard, grounds, outbuildings, and common areas surrounding the residence.
- [(h)] (J) "Respondent" means an individual alleged in a petition to have committed an act specified in § 3–1503(a) of this subtitle against a petitioner OR A PETITIONER'S EMPLOYEE.
- 21 **[(i)] (K)** "Temporary peace order" means a peace order issued by a judge under 22 § 3–1504 of this subtitle.
- 23 3-1502.
- 24 (a) By proceeding under this subtitle, a petitioner is not limited to or precluded 25 from pursuing any other legal remedy.
- 26 (b) This subtitle does not apply to:
- 27 (1) A petitioner **OR A PETITIONER'S EMPLOYEE** who is a person eligible 28 for relief, as defined in § 4–501 of the Family Law Article; or
- 29 (2) A respondent who is a child at the time of the alleged commission of an 30 act specified in § 3–1503(a) of this subtitle.

1 3-1503. 2 (a) A petitioner may seek relief under this subtitle by filing with the court, 3 or with a commissioner under the circumstances specified in § 3–1503.1(a) of this subtitle, 4 a petition that alleges the commission of any of the following acts against the petitioner, OR ANY OF THE FOLLOWING ACTS AGAINST THE PETITIONER'S EMPLOYEE AT THE 5 6 EMPLOYEE'S WORKPLACE, by the respondent, if the act occurred within 30 days before 7 the filing of the petition: 8 (i) An act that causes serious bodily harm; 9 An act that places the petitioner OR THE PETITIONER'S (ii) 10 **EMPLOYEE** in fear of imminent serious bodily harm; 11 (iii) Assault in any degree; 12 (iv) Rape or sexual offense under § 3–303, § 3–304, § 3–307, or § 13 3–308 of the Criminal Law Article or attempted rape or sexual offense in any degree; 14 (v) False imprisonment; 15 (vi) Harassment under § 3–803 of the Criminal Law Article; Stalking under § 3–802 of the Criminal Law Article; 16 (vii) 17 Trespass under Title 6, Subtitle 4 of the Criminal Law Article; (viii) 18 (ix) Malicious destruction of property under § 6–301 of the Criminal Law Article: 19 20 (x) Misuse of telephone facilities and equipment under § 3–804 of 21the Criminal Law Article; 22 (xi) Misuse of electronic communication or interactive computer 23 service under § 3–805 of the Criminal Law Article; 24Revenge porn under § 3–809 of the Criminal Law Article; or (xii) 25(xiii) Visual surveillance under § 3–901, § 3–902, or § 3–903 of the 26 Criminal Law Article. 27 (2) A petition may be filed under this subtitle if:

- 1 (ii) The petitioner **OR THE PETITIONER'S EMPLOYEE** is a resident of the State, regardless of whether the act described in paragraph (1) of this subsection is alleged to have occurred in the State.
- 4 (b) (1) The petition shall:
- 5 (i) Be under oath and provide notice to the petitioner that an 6 individual who knowingly provides false information in the petition is guilty of a 7 misdemeanor and on conviction is subject to the penalties specified in subsection (d) of this 8 section;
- 9 (ii) Subject to the provisions of subsection (c) of this section, contain 10 the address of the petitioner **OR THE PETITIONER'S EMPLOYEE**; and
- 11 (iii) Include all information known to the petitioner of:
- 1. The nature and extent of the act specified in subsection (a) of this section for which the relief is being sought, including information known to the petitioner concerning previous harm or injury resulting from an act specified in subsection (a) of this section by the respondent;
- 16 2. Each previous and pending action between the parties in 17 any court; and
- 18 3. The whereabouts of the respondent.
- 19 (c) If, in a proceeding under this subtitle, a petitioner **OR A PETITIONER'S**20 **EMPLOYEE** alleges, and the commissioner or judge finds, that the disclosure of the address
  21 of the petitioner **OR THE PETITIONER'S EMPLOYEE** would risk further harm to the
  22 petitioner **OR THE PETITIONER'S EMPLOYEE**, that address may be stricken from the
  23 petition and omitted from all other documents filed with the commissioner or filed with, or
  24 transferred to, a court.
- 25 (d) An individual who knowingly provides false information in a petition filed 26 under this section is guilty of a misdemeanor and on conviction is subject to a fine not 27 exceeding \$1,000 or imprisonment not exceeding 90 days or both.
- 28 **(E) (1)** AN EMPLOYER SHALL NOTIFY AN EMPLOYEE BEFORE AN 29 EMPLOYER FILES A PETITION UNDER THIS SUBTITLE.
- 30 (2) AN EMPLOYER SHALL BE IMMUNE FROM ANY CIVIL LIABILITY 31 THAT MAY RESULT FROM THE FAILURE OF THE EMPLOYER TO FILE A PETITION ON 32 BEHALF OF AN EMPLOYEE UNDER THE PROVISIONS OF THIS SUBTITLE.
- 33 (3) AN EMPLOYER MAY NOT RETALIATE AGAINST AN EMPLOYEE WHO 34 DOES NOT PROVIDE INFORMATION FOR OR TESTIFY AT A PROCEEDING UNDER THIS

- 17 (ii) Refrain from contacting, attempting to contact, or harassing the 18 petitioner **OR THE PETITIONER'S EMPLOYEE**;
- 19 (iii) Refrain from entering the residence of the petitioner **OR THE** 20 **PETITIONER'S EMPLOYEE**; and
- 21 (iv) Remain away from the place of employment, school, or temporary 22 residence of the petitioner **OR THE PETITIONER'S EMPLOYEE**.
- 23 (d) (1) (i) An interim peace order shall state the date, time, and location 24 for the temporary peace order hearing and a tentative date, time, and location for a final 25 peace order hearing.
- 26 (ii) Except as provided in subsection (g) of this section, or unless the court continues the hearing for good cause, a temporary peace order hearing shall be held on the first or second day on which a District Court judge is sitting after issuance of the interim peace order.
- 30 (2) An interim peace order shall include in at least 10–point bold type:
- 31 (i) Notice to the respondent that:

1 1. The respondent must give the court written notice of each 2 change of address; 3 2. If the respondent fails to appear at the temporary peace 4 order hearing or any later hearing, the respondent may be served with any other orders or 5 notices in the case by first-class mail at the respondent's last known address; 6 The date, time, and location of the final peace order 3. 7 hearing is tentative only, and subject to change; and 8 If the respondent does not attend the temporary peace 4. 9 order hearing, the respondent may call the Office of the Clerk of the District Court at the 10 number provided in the order to find out the actual date, time, and location of any final 11 peace order hearing: 12 A statement of all possible forms and duration of relief that a 13 temporary peace order or final peace order may contain; 14 Notice to the petitioner, PETITIONER'S EMPLOYEE, and (iii) 15 respondent that, at the hearing, a judge may issue a temporary peace order that grants any or all of the relief requested in the petition or may deny the petition, whether or not the 16 17 respondent is in court; 18 A warning to the respondent that violation of an interim peace (iv) 19 order is a crime and that a law enforcement officer shall arrest the respondent, with or 20without a warrant, and take the respondent into custody if the officer has probable cause 21 to believe that the respondent has violated any provision of the interim peace order; and 22The phone number of the Office of the District Court Clerk. (v) 23(e) Whenever a commissioner issues an interim peace order, the commissioner shall: 2425(1) Immediately forward a copy of the petition and interim peace order to 26 the appropriate law enforcement agency for service on the respondent; and 27 Before the hearing scheduled in the interim peace order, transfer the (2)28 case file and the return of service, if any, to the Office of the District Court Clerk. A law enforcement officer shall: 29 (f) 30 Immediately on receipt of a petition and interim peace order, serve them on the respondent named in the order; and 31

32 (2) Immediately after service, make a return of service to the 33 commissioner's office or, if the Office of the District Court Clerk is open for business, to the 34 clerk.

- 1 (1) Except as otherwise provided in this subsection, an interim peace order (g) 2 shall be effective until the earlier of: 3 (i) The temporary peace order hearing under § 3–1504 of this subtitle; or 4 5 The end of the second business day the Office of the Clerk of the (ii) 6 District Court is open following the issuance of an interim peace order. 7 (2)If the court is closed on the day on which the interim peace order is due to expire, the interim peace order shall be effective until the next day on which the court is 8 9 open, at which time the court shall hold a temporary peace order hearing. 10 (h) A decision of a commissioner to grant or deny relief under this section is not binding on, and does not affect any power granted to or duty imposed on, a judge of a circuit 11 12 court or the District Court under any law, including any power to grant or deny a petition 13 for a temporary peace order or final peace order. 14 An individual who knowingly provides false information in a petition filed under this section is guilty of a misdemeanor and on conviction is subject to a fine not 15 16 exceeding \$1,000 or imprisonment not exceeding 90 days or both. 17 3-1504. 18 If after a hearing on a petition, whether ex parte or otherwise, a judge (a) 19 finds that there are reasonable grounds to believe that the respondent has committed, and is likely to commit in the future, an act specified in § 3–1503(a) of this subtitle against the 20petitioner OR THE PETITIONER'S EMPLOYEE, the judge may issue a temporary peace 21order to protect the petitioner OR THE PETITIONER'S EMPLOYEE. 22 23 (2) The temporary peace order may include any or all of the following relief:
- 24 (i) Order the respondent to refrain from committing or threatening



- 31 (iv) Order the respondent to remain away from the place of 32 employment, school, or temporary residence of the petitioner **OR THE PETITIONER'S** 33 **EMPLOYEE**.

- 1 (3) If the judge issues an order under this section, the order shall contain 2 only the relief that is minimally necessary to protect the petitioner **OR THE PETITIONER'S** 3 **EMPLOYEE**.
- 4 (b) (1) Except as provided in paragraph (2) of this subsection, a law 5 enforcement officer immediately shall serve the temporary peace order on the respondent.
- 6 (2) A respondent who has been served with an interim peace order under § 3–1503.1 of this subtitle shall be served with the temporary peace order in open court or, if the respondent is not present at the temporary peace order hearing, by first–class mail at the respondent's last known address.
- 10 (c) (1) Except as otherwise provided in this subsection, the temporary peace 11 order shall be effective for not more than 7 days after service of the order.
- 12 (2) The judge may extend the temporary peace order as needed, but not to exceed 30 days, to effectuate service of the order where necessary to provide protection or 14 for other good cause.
- 15 (3) If the court is closed on the day on which the temporary peace order is 16 due to expire, the temporary peace order shall be effective until the second day on which 17 the court is open, by which time the court shall hold a final peace order hearing.
- 18 (d) The judge may proceed with a final peace order hearing instead of a temporary 19 peace order hearing if:
- 20 (1) (i) The respondent appears at the hearing;
- 21 (ii) The respondent has been served with an interim peace order; or

- 29 (b) (1) (i) The temporary peace order shall state the date and time of the 30 final peace order hearing.
- 31 (ii) Except as provided in § 3–1504(c) of this subtitle, or unless 32 continued for good cause, the final peace order hearing shall be held no later than 7 days

- 8 (5) "Victim services provider" means a nonprofit or governmental organization that has been authorized by the Governor's Office of Crime Control and Prevention to have online access to records of shielded peace orders in order to assist victims of abuse.
  - (b) (1) Subject to subsection (c) of this section, if a petition filed under this subtitle was denied or dismissed at the interim, temporary, or final peace order stage of a proceeding under this subtitle, the petitioner, **THE PETITIONER'S EMPLOYEE**, or the respondent may file a written request to shield all court records relating to the proceeding in accordance with subsection (d) of this section.
- 17 (2) Subject to subsection (c) of this section, if the respondent consented to the entry of a peace order under this subtitle, the petitioner, **THE PETITIONER'S**19 **EMPLOYEE**, or the respondent may file a written request to shield all court records relating to the proceeding in accordance with subsection (e) of this section.
- 21 (c) A request for shielding under this section may not be filed within 3 years after 22 the denial or dismissal of the petition or the consent to the entry of the peace order unless 23 the requesting party files with the request a general waiver and release of all the party's 24 tort claims related to the proceeding under this subtitle.
  - (d) (1) If a petition was denied or dismissed at the interim, temporary, or final peace order stage of a proceeding under this subtitle, on the filing of a written request for shielding under this section, the court shall schedule a hearing on the request.
- 28 (2) The court shall give notice of the hearing to the other party or the other 29 party's counsel of record.
- 30 (3) Except as provided in paragraphs (4) and (5) of this subsection, after the hearing, the court shall order the shielding of all court records relating to the proceeding if the court finds:
- 33 (i) That the petition was denied or dismissed at the interim, 34 temporary, or final peace order stage of the proceeding;
