A BILL

To amend title V of the Social Security Act to support stillbirth prevention and research, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Maternal and Child*
5 *Health Stillbirth Prevention Act of 2024”.*

6 **SEC. 2. CLARIFICATION SUPPORTING PERMISSIBLE USE OF**
7 **FUNDS FOR STILLBIRTH PREVENTION AC-**
8 **TIVITIES.**

9 *Section 501(a) of the Social Security Act (42 U.S.C.*
10 *701(a)) is amended—*

11 *(1) in paragraph (1)(B), by inserting “to reduce*
12 *the incidence of stillbirth,” after “among children,”;*
13 *and*

14 *(2) in paragraph (2), by inserting after “follow-*
15 *up services” the following: “, and for evidence-based*
16 *programs and activities and outcome research to re-*
17 *duce the incidence of stillbirth (including tracking*
18 *and awareness of fetal movements, improvement of*
19 *birth timing for pregnancies with risk factors, initia-*
20 *tives that encourage safe sleeping positions during*
21 *pregnancy, screening and surveillance for fetal growth*
22 *restriction, efforts to achieve smoking cessation during*
23 *pregnancy, community-based programs that provide*
24 *home visits or other types of support, and any other*

- 1 *research or evidence-based programming to prevent*
- 2 *stillbirths)*".
