## A BILL ENTITLED

1 AN ACT concerning

2 **Family Law – Child Custody – Determinations**

3 FOR the purpose of authorizing the court, in determining legal and physical custody in  
4 certain child custody proceedings, to consider certain factors; authorizing the court  
5 to modify a child custody or visitation order under certain circumstances; and  
6 generally relating to child custody and visitation.

7 BY repealing and reenacting, without amendments,  
8 Article – Family Law  
9 Section 9–101, 9–101.1, and 9–101.2  
10 Annotated Code of Maryland  
11 (2019 Replacement Volume and 2024 Supplement)

12 BY adding to  
13 Article – Family Law  
14 Section 9–201 and 9–202 to be under the new subtitle “Subtitle 2. Legal and Physical  
15 Custody – Judicial Determinations”  
16 Annotated Code of Maryland  
17 (2019 Replacement Volume and 2024 Supplement)

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
19 That the Laws of Maryland read as follows:

20 **Article – Family Law**

21 9–101.

22 (a) In any custody or visitation proceeding, if the court has reasonable grounds to  
23 believe that a child has been abused or neglected by a party to the proceeding, the court  
24 shall determine whether abuse or neglect is likely to occur if custody or visitation rights  
25 are granted to the party.

1 (b) Unless the court specifically finds that there is no likelihood of further child  
2 abuse or neglect by the party, the court shall deny custody or visitation rights to that party,  
3 except that the court may approve a supervised visitation arrangement that assures the  
4 safety and the physiological, psychological, and emotional well-being of the child.

6 (a) In this section, “abuse” has the meaning stated in § 4–501 of this article.

7 (b) In a custody or visitation proceeding, the court shall consider, when deciding  
8 custody or visitation issues, evidence of abuse by a party against:

9 (1) the other parent of the party’s child;

10 (2) the party’s spouse; or

11 (3) any child residing within the party’s household, including a child other  
12 than the child who is the subject of the custody or visitation proceeding.

13 (c) If the court finds that a party has committed abuse against the other parent  
14 of the party’s child, the party’s spouse, or any child residing within the party’s household,  
15 the court shall make arrangements for custody or visitation that best protect:

16 (1) the child who is the subject of the proceeding; and

17 (2) the victim of the abuse.

19 (a) Except as provided in subsection (b) of this section, unless good cause for the  
20 award of custody or visitation is shown by clear and convincing evidence, a court may not  
21 award custody of a child or visitation with a child:

22 (1) to a parent who has been found by a court of this State to be guilty of  
23 first degree or second degree murder of the other parent of the child, another child of the  
24 parent, or any family member residing in the household of either parent of the child; or

25 (2) to a parent who has been found by a court of any state or of the United  
26 States to be guilty of a crime that, if committed in this State, would be first degree murder  
27 or second degree murder of the other parent of the child, another child of the parent, or any  
28 family member residing in the household of either parent of the child.

29 (b) If it is in the best interest of the child, the court may approve a supervised  
30 visitation arrangement that assures the safety and the physiological, psychological, and  
31 emotional well-being of the child.

3           **(A) SUBJECT TO THE PROVISIONS OF §§ 9–101, 9–101.1, AND 9–101.2 OF**  
4 **THIS TITLE, IN DETERMINING WHAT LEGAL CUSTODY AND PHYSICAL CUSTODY IS IN**  
5 **THE BEST INTEREST OF A CHILD, THE COURT MAY CONSIDER THE FOLLOWING**  
6 **FACTORS:**

7                   **(1) STABILITY AND THE FORESEEABLE HEALTH AND WELFARE OF THE**  
8 **CHILD;**

9                   **(2) FREQUENT, REGULAR, AND CONTINUING CONTACT WITH PARENTS**  
10 **WHO CAN ACT IN THE CHILD’S BEST INTEREST;**

11                   **(3) WHETHER AND HOW PARENTS WHO DO NOT LIVE TOGETHER WILL**  
12 **SHARE THE RIGHTS AND RESPONSIBILITIES OF RAISING THE CHILD;**

13                   **(4) THE CHILD’S RELATIONSHIP WITH EACH PARENT, ANY SIBLINGS,**  
14 **OTHER RELATIVES, AND INDIVIDUALS WHO ARE OR MAY BECOME IMPORTANT IN THE**  
15 **CHILD’S LIFE;**

16                   **(5) THE CHILD’S PHYSICAL AND EMOTIONAL SECURITY AND**  
17 **PROTECTION FROM EXPOSURE TO CONFLICT AND VIOLENCE;**

18                   **(6) THE CHILD’S DEVELOPMENTAL NEEDS, INCLUDING PHYSICAL**  
19 **SAFETY, EMOTIONAL SECURITY, POSITIVE SELF-IMAGE, INTERPERSONAL SKILLS,**  
20 **AND INTELLECTUAL AND COGNITIVE GROWTH;**

21                   **(7) THE DAY-TO-DAY NEEDS OF THE CHILD, INCLUDING EDUCATION,**  
22 **SOCIALIZATION, CULTURE AND RELIGION, FOOD, SHELTER, CLOTHING, AND**  
23 **MENTAL AND PHYSICAL HEALTH;**

24                   **(8) HOW TO:**

25                           **(I) PLACE THE CHILD’S NEEDS ABOVE THE PARENTS’ NEEDS;**

26                           **(II) PROTECT THE CHILD FROM THE NEGATIVE EFFECTS OF ANY**  
27 **CONFLICT BETWEEN THE PARENTS; AND**

28                           **(III) MAINTAIN THE CHILD’S RELATIONSHIP WITH THE PARENTS,**  
29 **SIBLINGS, OTHER RELATIVES, OR OTHER INDIVIDUALS WHO HAVE OR LIKELY MAY**  
30 **HAVE A SIGNIFICANT RELATIONSHIP WITH THE CHILD;**

1           **(9) THE AGE OF THE CHILD;**

2           **(10) ANY MILITARY DEPLOYMENT OF A PARENT AND ITS EFFECT, IF**  
3 **ANY, ON THE PARENT-CHILD RELATIONSHIP;**

4           **(11) ANY PRIOR COURT ORDERS OR AGREEMENTS;**

5           **(12) EACH PARENT'S ROLE AND TASKS RELATED TO THE CHILD AND**  
6 **HOW, IF AT ALL, THOSE ROLES AND TASKS HAVE CHANGED;**

7           **(13) THE LOCATION OF EACH PARENT'S HOME AS IT RELATES TO THE**  
8 **PARENT'S ABILITY TO COORDINATE PARENTING TIME, SCHOOL, AND ACTIVITIES;**

9           **(14) THE PARENTS' RELATIONSHIP WITH EACH OTHER, INCLUDING:**

10           **(I) HOW THEY COMMUNICATE WITH EACH OTHER;**

11           **(II) WHETHER THEY CAN CO-PARENT WITHOUT DISRUPTING**  
12 **THE CHILD'S SOCIAL AND SCHOOL LIFE; AND**

13           **(III) HOW THE PARENTS WILL RESOLVE ANY DISPUTES IN THE**  
14 **FUTURE WITHOUT THE NEED FOR COURT INTERVENTION;**

15           **(15) THE CHILD'S PREFERENCE, IF AGE-APPROPRIATE; AND**

16           **(16) ANY OTHER FACTOR THAT THE COURT CONSIDERS APPROPRIATE**  
17 **IN DETERMINING HOW BEST TO SERVE THE PHYSICAL, DEVELOPMENTAL, AND**  
18 **EMOTIONAL NEEDS OF THE CHILD.**

19           **(B) THE COURT SHALL ARTICULATE ITS FINDINGS OF FACT ON THE RECORD**  
20 **OR IN A WRITTEN OPINION, INCLUDING THE CONSIDERATION OF EACH FACTOR**  
21 **LISTED IN SUBSECTION (A) OF THIS SECTION AND ANY OTHER FACTOR THAT THE**  
22 **COURT CONSIDERED.**

24           **(A) THE COURT MAY MODIFY, IN ACCORDANCE WITH THE PROVISIONS OF**  
25 **THIS SUBTITLE, A CHILD CUSTODY OR VISITATION ORDER IF THE COURT**  
26 **DETERMINES THAT THERE HAS BEEN A MATERIAL CHANGE IN CIRCUMSTANCES**  
27 **SINCE THE ISSUANCE OF THE ORDER THAT RELATES TO THE NEEDS OF THE CHILD**  
28 **OR THE ABILITY OF THE PARENTS TO MEET THOSE NEEDS AND THAT MODIFYING THE**  
29 **ORDER IS IN THE BEST INTEREST OF THE CHILD.**

30           **(B) A PARENT'S PROPOSAL TO RELOCATE THE RESIDENCE OF THE PARENT**

1 OR THE CHILD IN A WAY THAT WOULD CAUSE PHYSICAL CUSTODY TO BE  
2 IMPRACTICABLE CONSTITUTES A MATERIAL CHANGE IN CIRCUMSTANCES.

3 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
4 October 1, 2025.
