## RESOLUTION

Relating to proceedings of the Senate in the event of a partial or full shutdown of the Federal Government.

1 Resolved,

AUTHENTICATED U.S. GOVERNMENT INFORMATION

2 SECTION 1. SHORT TITLE.

3 This resolution may be cited as the "Shutdown Ac-4 countability Resolution".

5 SEC. 2. PROCEEDINGS OF THE SENATE DURING A FULL OR

6 PARTIAL GOVERNMENT SHUTDOWN.

7 (a) DEFINITION.—In this section, the term "Govern8 ment shutdown" means a lapse in appropriations for 1
9 or more agencies of the Federal Government.

10 (b) CONVENING OF THE SENATE.—

| 1  | (1) IN GENERAL.—Notwithstanding any rule or           |

| 4  | (A) the Senate shall convene at 8:00 a.m.             |

| 8  | the Presiding Officer shall not entertain a re-       |
| 9  | quest for, unanimous consent to change the            |
| 10 | hour or day on which the Senate shall convene         |
| 11 | under subparagraph (A).                               |
| 12 | (2) Senate not in session.—If the Senate is           |
| 13 | not in session on the first calendar day of a Govern- |
| 14 | ment shutdown, the majority leader, after consulta-   |
| 15 | tion with the minority leader, shall notify Members   |
| 16 | of the Senate that, pursuant to this standing order,  |
| 17 | the Senate shall convene at 8:00 a.m. on the next     |
| 18 | calendar day of the Government shutdown.              |
| 19 | (c) PRESENCE OF A QUORUM.—                            |
| 20 | (1) IN GENERAL.—During the period of a Gov-           |
| 21 | ernment shutdown, and notwithstanding any provi-      |
| 22 | sion of the Standing Rules of the Senate—             |
| 23 | (A) immediately after the Presiding Officer           |
| 24 | takes the chair in accordance with rule IV of         |
| 25 | the Standing Rules of the Senate, the Presiding       |

| 1  | Officer shall direct the Clerk to call the roll to |

| 2  | ascertain the presence of a quorum; and            |
| 3  | (B) 1 hour after the presence of a quorum          |
| 4  | has last been demonstrated, the Presiding Offi-    |
| 5  | cer shall direct the Clerk to call the roll to as- |

| 7  | (2) Lack of quorum.—                               |
| 8  | (A) IN GENERAL.—If, upon a calling of the          |
| 9  | roll under paragraph (1), it shall be ascertained  |
| 10 | that a quorum is not present—                      |
| 11 | (i) the Presiding Officer shall direct             |
| 12 | the Clerk to call the names of any absent          |
| 13 | Senators; and                                      |
| 14 | (ii) following the calling of the names            |
| 15 | under clause (i), the Presiding Officer            |
| 16 | shall, without intervening motion or de-           |
| 17 | bate, submit to the Senate by a yea-and-           |
| 18 | nay vote the question: "Shall the Sergeant-        |
| 19 | at-Arms be directed to request the attend-         |
| 20 | ance of absent Senators?".                         |
| 21 | (B) DIRECTION TO COMPEL ATTEND-                    |
| 22 | ANCE.—If a quorum is not present 15 minutes        |
| 23 | after the time at which the vote on a question     |
| 24 | submitted under subparagraph (A)(ii) starts,       |
| 25 | the Presiding Officer shall, without intervening   |

motion or debate, submit to the Senate by a yea-and-nay vote the question: "Shall the Sergeant-at-Arms be directed to compel the attendance of absent Senators?".

5 (C) ARREST OF ABSENT SENATORS.—Ef-6 fective 1 hour after the Sergeant-at-Arms is di-7 rected to compel the attendance of absent Sen-8 ators under subparagraph (B), if any Senator 9 not excused under rule XII of the Standing 10 Rules of the Senate is not in attendance, the 11 Senate shall be deemed to have agreed an order 12 that reads as follows: "Ordered, That the Ser-13 geant-at-Arms be directed to arrest absent Sen-14 ators; that warrants for the arrests of all Sen-15 ators not sick nor excused be issued under the 16 signature of the Presiding Officer and attested 17 by the Secretary, and that such warrants be ex-18 ecuted without delay.".

(D) REPORTS.—Not less frequently than
once per hour during proceedings to compel the
attendance of absent Senators, the Sergeant-atArms shall submit to the Senate a report on absent Senators, which shall—

(i) be laid before the Senate;

| 12 | a quorum is established, that Senator shall be enti-   |
| 13 | tled to be recognized to speak.                        |
| 14 | (d) Adjourning and Recessing.—During the pe-           |
| 15 | riod of a Government shutdown—                         |
| 16 | (1) a motion to adjourn or to recess the Senate        |
| 17 | shall be decided by a yea-or-nay vote;                 |
| 18 | (2) if a quorum is present, the Presiding Offi-        |
| 19 | cer shall not entertain a request to adjourn or recess |
| 20 | the Senate by unanimous consent or to vitiate the      |
| 21 | yeas and nays on such a motion by unanimous con-       |
| 22 | sent;  |
| 23 | (3) a motion to adjourn or a motion to recess          |
| 24 | made during the period beginning at 8:00 a.m. and      |
| 25 | ending at 11:59 p.m., shall only be agreed to upon     |
|    |  |

an affirmative vote of two-thirds of the Senators
present and voting, a quorum being present; and
(4) if the Senate must adjourn due to the absence of a quorum, the Senate shall reconvene 2
hours after the time at which it adjourns and ascertain the presence of a quorum in accordance with
subsection (c)(1).

8 (e) NO SUSPENSION OF REQUIREMENTS.—The Pre-9 siding Officer may not entertain a request to suspend the 10 operation of this standing order by unanimous consent or 11 motion.

(f) CONSISTENCY WITH SENATE EMERGENCY PROCEDURES AND PRACTICES.—Nothing in this standing
order shall be construed in a manner that is inconsistent
with S. Res. 296 (108th Congress) or any other emergency
procedures or practices of the Senate.

17 (g) STANDING ORDER.—This section shall be a18 standing order of the Senate.

0
