## 2017 ASSEMBLY BILL 419

June 30, 2017 - Introduced by Representatives RODRIGUEZ, CROWLEY, TITTL and TUSLER, cosponsored by Senators DARLING, LARSON, L. TAYLOR and CARPENTER. Referred to Committee on Education.

1     **AN ACT** *to amend* 119.04 (1); and *to create* 20.255 (2) (fh) and 115.413 of the  
2             statutes; **relating to:** professional development training in character  
3             education for teachers, principals, and school district administrators, granting  
4             rule-making authority, and making an appropriation.

***Analysis by the Legislative Reference Bureau***

This bill authorizes the Department of Public Instruction to award grants to school districts for teachers, principals, and school district administrators to participate in professional development trainings in character education. The bill also requires DPI to count professional development training in character development towards any professional development requirements for teacher or administrator licensure.
